COMMENCING AT THE NORTHWEST CORNER OF THE SAID SOUTHWEST QUARTER; THENCE SOUTH 02 DEGREES 12 MINUTES 21 SECONDS WEST 1465.82 FEET TO AN IRON PIN SET, SAID POINT BEING THE PLACE OF BEGINNING OF THE TRACT HEREIN INTENDED TO BE DESCRIBED; THENCE NORTH 83 DEGREES 19 MINUTES 15 SECONDS EAST 647.59 FEET TO AN IRON PIN SET; THENCE NORTH 85 DEGREES 54 MINUTES 09 SECONDS EAST 399.29 FEET TO AN IRON PIN SET; THENCE NORTH 79 DEGREES 25 MINUTES 29 SECONDS EAST 450.64 FEET TO AN IRON PIN SET; THENCE NORTH 81 DEGREES 57 MINUTES 42 SECONDS EAST 530.65 FEET TO A POINT IN THE CENTER OF TOWNSHIP ROAD NUMBER 65 (HARDESTY ROAD), PASSING AN IRON PIN SET AT 513.74 FEET; THENCE WITH THE SAID ROAD, NORTH 06 DEGREES 03 MINUTES 17 SECONDS EAST 101.48 FEET TO A POINT IN THE SAID CENTER; THENCE LEAVING THE SAID ROAD, NORTH 89 DEGREES 37 MINUTES 54 SECONDS EAST 648.77 FEET TO AN IRON PIN SET ON THE EAST LIEN OF THE SAID SOUTHWEST QUARTER OF SECTION 23, PASSING AN IRON PIN SET AT 17.33 FEET; THENCE WITH THE SAID EAST LINE SOUTH 02 DEGREES 31 MINUTES 39 SECONDS WEST 1033.44 FEET TO A POINT IN COUNTY ROAD NUMBER 107 (CLAY PIKE) AT THE NORTHEAST CORNER OF A TRACT CONVEYED TO M. J. HIEBERT BY DEED RECORDED IN VOLUME 811, PAGE 25 OF THE MUSKINGUM COUNTY DEED RECORDS, PASSING AN IRON PIN SET AT 1003.44 FEET; THENCE WITH THE SAID COUNTY ROAD AND THE NORTH LINE OF THE SAID HIEBERT TRACT THE NEXT FIVE COURSES AND DISTANCES:

- 1) WITH A CURVE TO THE LEFT HAVING A RADIUS OF 594.24 FEET (CHORD BEARING SOUTH 65 DEGREES 54 MINUTES 51 SECONDS WEST 492.81 FEET) AN ARC DISTANCE OF 508.15 FEET TO A POINT;
- 2) SOUTH 41 DEGREES 24 MINUTES 28 SECONDS WEST 59.33 FEET TO A POINT;
- 3) WITH A CURVE TO THE RIGHT HAVING A RADIUS OF 604.01 FEET (CHORD BEARING SOUTH 50 DEGREES 48 MINUTES 30 SECONDS WEST 197.24 FEET) AN ARC DISTANCE OF 198.13 FEET TO A POINT;
- 4) SOUTH 60 DEGREES 12 MINUTES 32 SECONDS WEST 259.03 FEET TO A POINT, SAID POINT BEING SOUTH 42 DEGREES 48 MINUTES 30 SECONDS WEST 66.69 FEET FROM AN IRON PIN SET;
