

**DEED DESCRIPTION
FOR
JAMES & THERESA McELWEE**

Situated in Union Township, Muskingum County, Ohio and being 6.091 acres more or less in Lot # 9 in Quarter Township # 4, Township # 1 North Range # 5 West of the United Military Lands Survey and being more particularly described as follows:

Commencing at an iron pin found at the Northwest corner of Lot # 9 in Quarter Township # 4, Thence with the north line of Lot # 9 S88°08'37"E a distance of 1806.43 feet to a survey angle point the **BEGINNING**, Thence continuing along the north line of Lot # 9 and with the lands of now or formerly J. & M. Yaw as found in Volume 786 Page 173 S88°08'37"E a distance of 384.38 feet to a survey angle point, Thence leaving the north line of Lot # 9 and with the lands of now or formerly Bradley R. Hockenberry as found in Volume 2136 Page 72 S01°51'55"W a distance of 11.80 feet to an iron pin found, Thence with a new division line through the lands of now or formerly James & Theresa McElwee as found in Volume 2201 Page 438 the following five (5) calls:

1. S22°24'55"W a distance of 349.03 feet to an iron pin set.
2. S14°13'19"W a distance of 201.99 feet to an iron pin found.
3. S13°40'26"W a distance of 216.54 feet to an iron pin found.
4. S13°40'26"W a distance of 98.37 feet to an iron pin set.
5. S86°42'24"W a distance of 288.05 feet to an iron pin found, Thence with the lands of now or formerly Donald & Ammie Aitken as found in Volume 2071 Page 788 the following two (2) calls:

1. N11°52'18"E a distance of 746.12 feet to an iron pin found.
2. N03°09'14"E a distance of 135.27 feet to the beginning (having passed through an iron pin found at a distance of 127.51 feet) and containing 6.091 acres more or less and being part of the property conveyed to James & Theresa McElwee as found in Volume 2201 Page 438.

Also reserving a right-of-way for an existing water well :

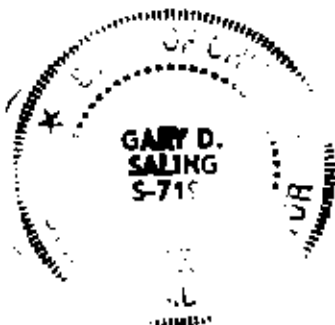
Commencing at the Northwest corner of the above described property, Thence S03°09'14"W a distance of 135.27 feet to an iron pin found, Thence S11°52'18"W a distance of 79.25 feet to a survey angle point, Thence N78°07'42"E a distance of 207.01 feet to an existing water well, Thence leaving said water well and with the centerline of a reputed water line N74°39'14"E a distance of 574.22 feet to an existing house.

Subject to all easements or leases of public record.

Iron pins set are 5/8 inch rebar 30 inches long, capped G. SALING- 7192.

Basis of bearings are for angle calculations and are based on the north line of Lot # 9 of Quarter Township # 4 and used as S88°08'37"E.
