- #14- thence S 17 51 40 E 153.94 feet continuing through said Tract Nine and along said road to a point from which an iron pin (set) for reference bears N 71 17 10 E 20.00 feet:
- #15- thence S 20 26 20 E 147.67 feet continuing through said Tract Nine and along said road to a point from which an iron pin (set) for reference bears S 74 32 00 W 20.00 feet;
- #16- thence S 23 29 30 E 181.85 feet continuing through said Tract Nine and along said road to the Northwest corner of the D Harmon property as described in deed reference Deed Book Volume 523, Page 926, from which an iron pin (found) on the North line of said Harmon property for reference bears S 89 15 00 E 25.00 feet:
- #17- thence S 23 39 40 E 115.00 feet along the West line of said Harmon property and continuing along said road to the South line for said Lot #14 and North line of Lot #17 also of said Township and Range, from which an iron pin (found) at the Southeast corner of said Lot #14 also being the common corner for Lots #13, #17, and #18 of said Township and Range, for reference bears S 87 54 40 E 438.31 feet;
- #18- thence N 87 54 40 W 903.61 feet along the common line of said Lots #14 and #17 to an iron pin (found) at the Northwest corner of the B& B Cubbison property and Northeast corner of Tract #7 of said Kansas State University property, passing an iron pin (found) at 25.00 feet;
- #19- thence N 87 45 20 W 1329.94 feet along continuing along the common line for said Lots #14 and #17 to an iron pin (found) at the common corner of Lots #14, #15, #16 and #17 of said Township and Range;
- #20- thence N 02 22 30 E 2660.31 feet along the common line for said Lots #14 & #15 to the place of beginning containing 120.12 acres.

The bearings within the description are based on State Plane Coordinate Grid derived from an average of numerous Solar Observation (Local Hour Angle Method). Observations were calculated with a range of + or - 27 seconds. Bearings are shown in a format of Degrees, Minutes, and Seconds. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness P.L.S.6885).
