T. MURPHY AND C. R. STOTTS AS RECORDED IN DEED BOOK VOLUME 898 PAGE 216 OF THE SAID COUNTY RECORDS; THENCE NORTH 04 DEGREES 54 MINUTES 00 SECONDS EAST 265.83 FEET ALONG THE WEST LINE OF SAID MURPHY TRACT TO AN EXISTING IRON PIN (3/4 INCH ID PIPE), SAID IRON PIN BEING THE PLACE OF BEGINNING OF THE TRACT HEREIN INTENDED TO BE DESCRIBED; THENCE NORTH 86 DEGREES 58 MINUTES 00 SECONDS WEST 133.02 FEET TO AN IRON PIN SET; THENCE NORTH 04 DEGREES 22 MINUTES 41 SECONDS EAST 487.10 FEET TO AN IRON PIN SET; THENCE SOUTH 86 DEGREES 58 MINUTES 00 SECONDS EAST 207.25 FEET TO AN IRON PIN SET; THENCE NORTH 04 DEGREES 22 MINUTES 41 SECONDS EAST 556.95 FEET TO THE CENTER LINE OF COUNTY ROAD NUMBER 4 (MEMORY ROAD), PASSING AN IRON PIN SET AT 536.95 FEET; THENCE SOUTH 89 DEGREES 57 MINUTES 56 SECONDS EAST 16.04 FEET ALONG THE SAID CENTER TO A POINT; THENCE SOUTH 04 DEGREES 22 MINUTES 41 SECONDS WEST 1044.89 FEET ALONG THE WEST LINE OF THE 0.40 MORE OR LESS ACRE PARCEL CONVEYED TO W. 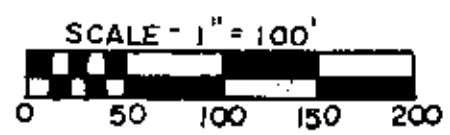
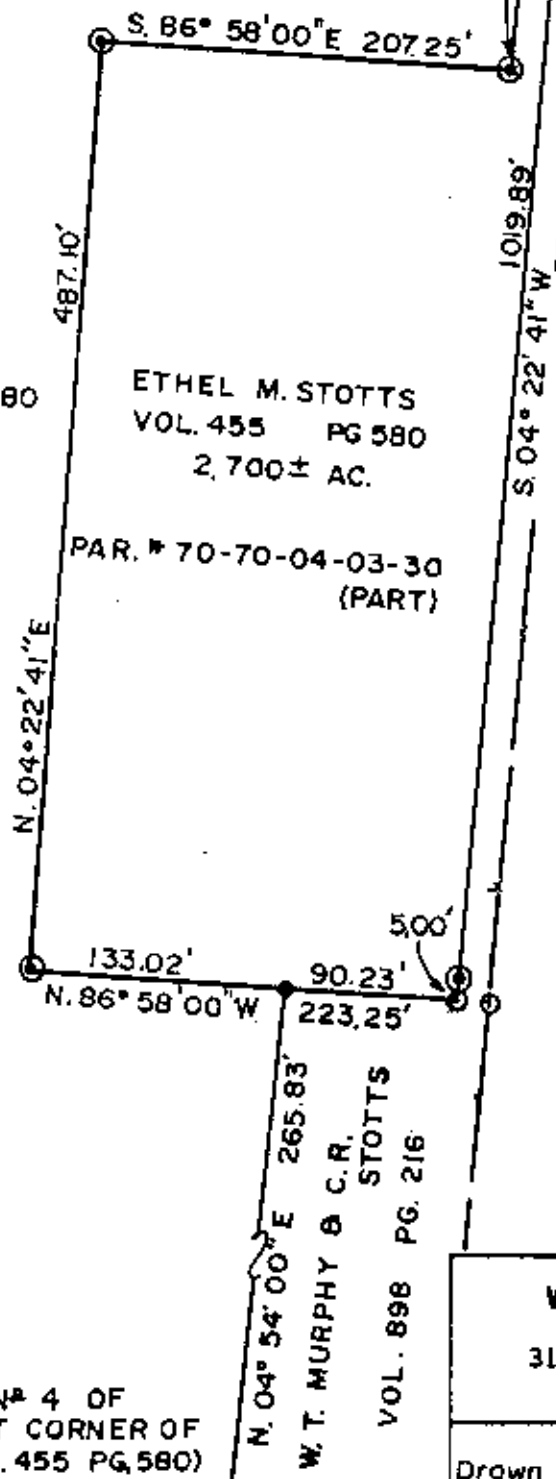
