thence continuing along said line South 78 degrees 06 minutes 26 seconds West 115.57 feet to a monument found;



No. 132) that are now owned by the Muskingum Recreational Trail as described in Muskingum County Deed Record 1122, page 47 that located on both sides of the following described centerline:

Beginning at a point on the Washington/Muskingum Township line in the center of the railroad bridge over the Muskingum River, said point is at centerline station 452+22.8;

thence 60 feet right and 55 feet left of the following described centerline South 12 degrees 28 minutes 15 seconds East 213.34 feet to centerline station 454+36.14;

thence on a spiral in to the right having a length of 209.96 feet to the point of curvature on a curve to the right having a radius of 1228.11 feet, a central angle of 37 degrees 42 minutes 22 seconds and an arc length of 808.21 feet to centerline station 464+54.31 feet, passing at centerline station 459+08.76 a change of right of way width to 50 feet on each side of the following described centerline;

thence on a spiral out to the right having a length of 259.91 feet to centerline station 467+14.22;

thence South 36 degrees 11 minutes 45 seconds West 398.20 feet to centerline station 471+12.42;
