Commencing at the Southwest Corner of Lot 15; thence along the west line of said Lot 15 north 1772.76 feet to the Northwest corner of a 106.94 acre parcel conveyed to Mildred McNeish by deed recorded in Deed Book 435, Page 422 of the records of Muskingum County; thence south 56 degrees 41 minutes 45 seconds east 938.51 feet to a point in Church Hill Road; thence along said road south 6 degrees 32 minutes 03 seconds east 69 feet to the northeast corner of a 1.49 acre parcel conveyed to Jeffrey A. McNeish and Charles F. McNeish by deed recorded in Deed Book 845, Page 140; thence along the north line of said 1.49 acre parcel south 82 degrees 58 minutes 32 seconds west 268.80 feet to the northwest corner of said 1.49 acre parcel; thence north 86 degrees 21 minutes 30 seconds west 82.26 feet to an iron pin and the true place of beginning of the premises herein intended to be described; thence south 5 degrees 42 minutes 36 seconds east 135.04 feet to an iron pin; thence south 83 degrees 25 minutes 18 seconds west 266.57 feet to an iron pin; thence north 3 degrees 26 minutes 26 seconds west 135.29 feet to an iron pin; thence north 83 degrees 26 minutes 06 seconds east 261.21 feet to the true place of beginning, containing eighty-two hundredths (0.82) of an acre more or less.



