

Survey for Township of Washington, Muskingum County

Being a part of land located in the State of Ohio, County of Muskingum, Washington Township, part of Lot 16 in quarter Township 4, Township 2 North, Range 7 West, United States Military Lands.

Being part of the lands conveyed to the Township of Washington, Muskingum County in Deed Record 1119, page 302, bounded and described as follows:

Commencing at the southeast corner of Lot 16 of quarter township 4, Township 2 North, Range 7 West;

thence along the east line of Lot 16 North 00 degrees 02 minutes 44 seconds East 1415.73 feet to an iron pin found;

thence leaving the east line of Lot 16 North 59 degrees 20 minutes 57 seconds West 148.91 feet to an iron pin found, being the northeast corner of William Bateman, et al., Trustees of the First Baptist Church in Washington Twp. (DR 61-197);

thence on the north line of William Bateman, et al., Trustees of the First Baptist Church in Washington Twp. (DR 61-197) North 59 degrees 20 minutes 57 seconds West 29.31 feet to an iron pin set, the **place of beginning** for this parcel;

thence continuing on the north line of William Bateman, et al., Trustees of the First Baptist Church in Washington Twp. (DR 61-197) North 59 degrees 20 minutes 57 seconds West 37.78 feet to an iron pin set;

thence leaving the north line of William Bateman, et al., Trustees of the First Baptist Church in Washington Twp. (DR 61-197) and through the property of the Township of Washington, Muskingum County (DR 1119-302) the following three courses:

1. North 28 degrees 51 minutes 06 seconds East 60.09 feet to an iron pin set;
2. South 62 degrees 08 minutes 12 seconds East 33.22 feet to an iron pin set;
3. South 24 degrees 38 minutes 43 seconds West 62.01 feet to the place of beginning, containing 0.05 acres, more or less.






