thence continuing through the Trustees of Washington Township (DR 326-221) North 87 degrees 33 minutes 46 seconds West 7.73 feet to a point, being the northwest corner of the Trustees of Washington Township (DR 326-221);

thence along the west line of the Trustees of Washington Township (DR 326-221) South 02 degrees 26 minutes 14 seconds West 79.83 feet to a point, referenced by an iron pin set South 86 degrees 37 minutes 45 seconds East 16.90 feet on the east right-of-way of State Route 93;

thence leaving the west line of the Trustees of Washington Township (DR 326-221) and through Donald D. and Brenda D. Madden (DR 2392-875) the following five courses:

- 1. North 86 degrees 37 minutes 45 seconds West 13.44 feet to a point in the centerline of State Route 93;
