Commencing at an existing stone at the Northwest corner of Lot
Number 8; thence South 01 degree 59 minutes 42 seconds West 212.00
feet along the West line of the said Lot 8 to a point in Township
Road 190 (Culbertson Road), said point being the place of
beginning of the tract herein intended to be described, also
passing an existing iron pin (5/8 inch rebar) at 192.00 feet;
thence with the said road and the south lines of a 3.596 more or
less acre and a 1.937 more or less acre tracts, North 85 degrees
12 minutes 02 seconds East 358.37 feet to a point, said point
being South 02 degrees 25 minutes 11 seconds West 18.16 feet from
an existing iron pin (5/8 inch rebar); thence continuing with the
said road North 82 degrees 35 minutes 00 seconds East 168.17 feet
to a point in the center of the said road; thence continuing with
the said road North 84 degrees 42 minutes 00 seconds East 103.01
feet to a point in the center of the said road; thence leaving the
said road, South 03 degrees 18 minutes 00 seconds West 125.00 feet
to an iron pin set, passing an iron pin set at 15.00 feet; thence

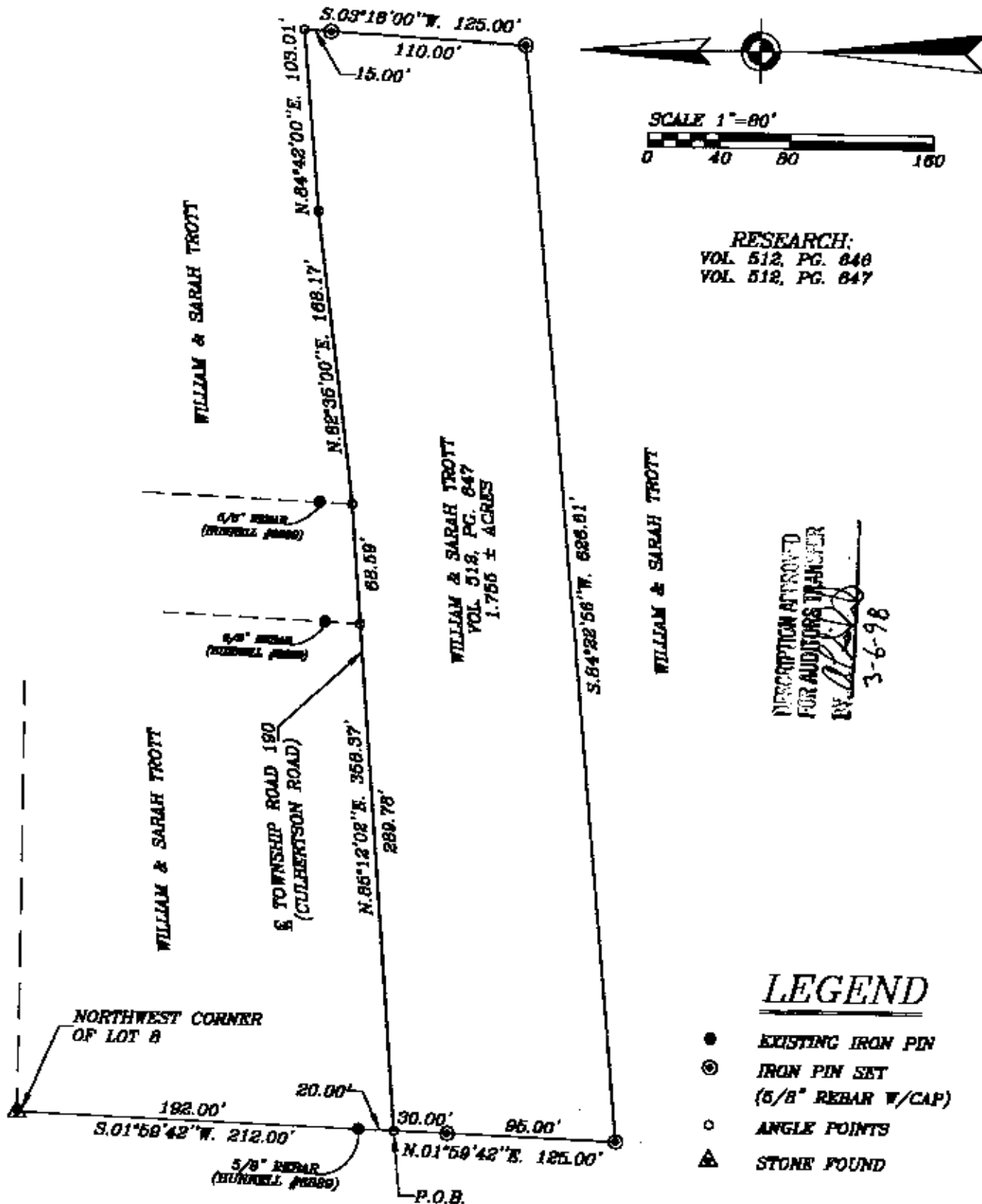

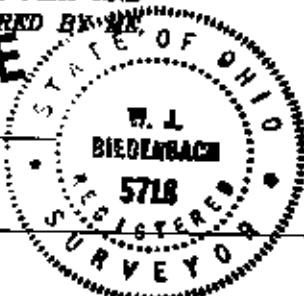
