COMMENCING AT AN EXISTING STONE AT THE NORTHWEST CORNER OF LOT NUMBER 8; THENCE SOUTH 01 DEGREES 59 MINUTES 42 SECONDS WEST 337.00 FEET TO AN EXISTING IRON PIN (5/8 INCH REBAR) AT THE SOUTHWEST CORNER OF A 1.755 MORE OR LESS ACRE TRACT;

THENCE SOUTH 02 DEGREES 05 MINUTES 47 SECONDS WEST 449.39 FEET TO AN IRON PIN SET;

THENCE WITH THE NORTH LINE OF A 69.858 ACRE TRACT CONVEYED TO JOHN MICHEL SOUTH 89 DEGREES 27 MINUTES 42 SECONDS EAST 910.33 FEET TO AN IRON PIN SET, SAID IRON PIN BEING THE PLACE OF BEGINNING OF THE TRACT HEREIN INTENDED TO BE DESCRIBED;

THENCE LEAVING THE SAID MICHEL LINE AND TRAVERSING THROUGH THE S. TROTT TRACT (VOLUME 1141, PAGE 735) THE NEXT FIVE COURSES AND DISTANCES;

- 2) NORTH 85 DEGREES 02 MINUTES 58 SECONDS EAST 45.18 FEET TO A POINT IN THE CENTER OF TOWNSHIP ROAD 190 (CULBERTSON ROAD);
- 3) NORTH 85 DEGREES 50 MINUTES 49 SECONDS EAST 92.81 FEET TO A POINT IN THE CENTER OF THE SAID ROAD;
- 4) NORTH 88 DEGREES 28 MINUTES 31 SECONDS EAST 100.86 FEET TO A POINT IN THE CENTER OF SAID ROAD;

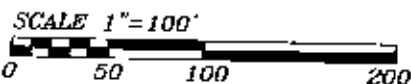

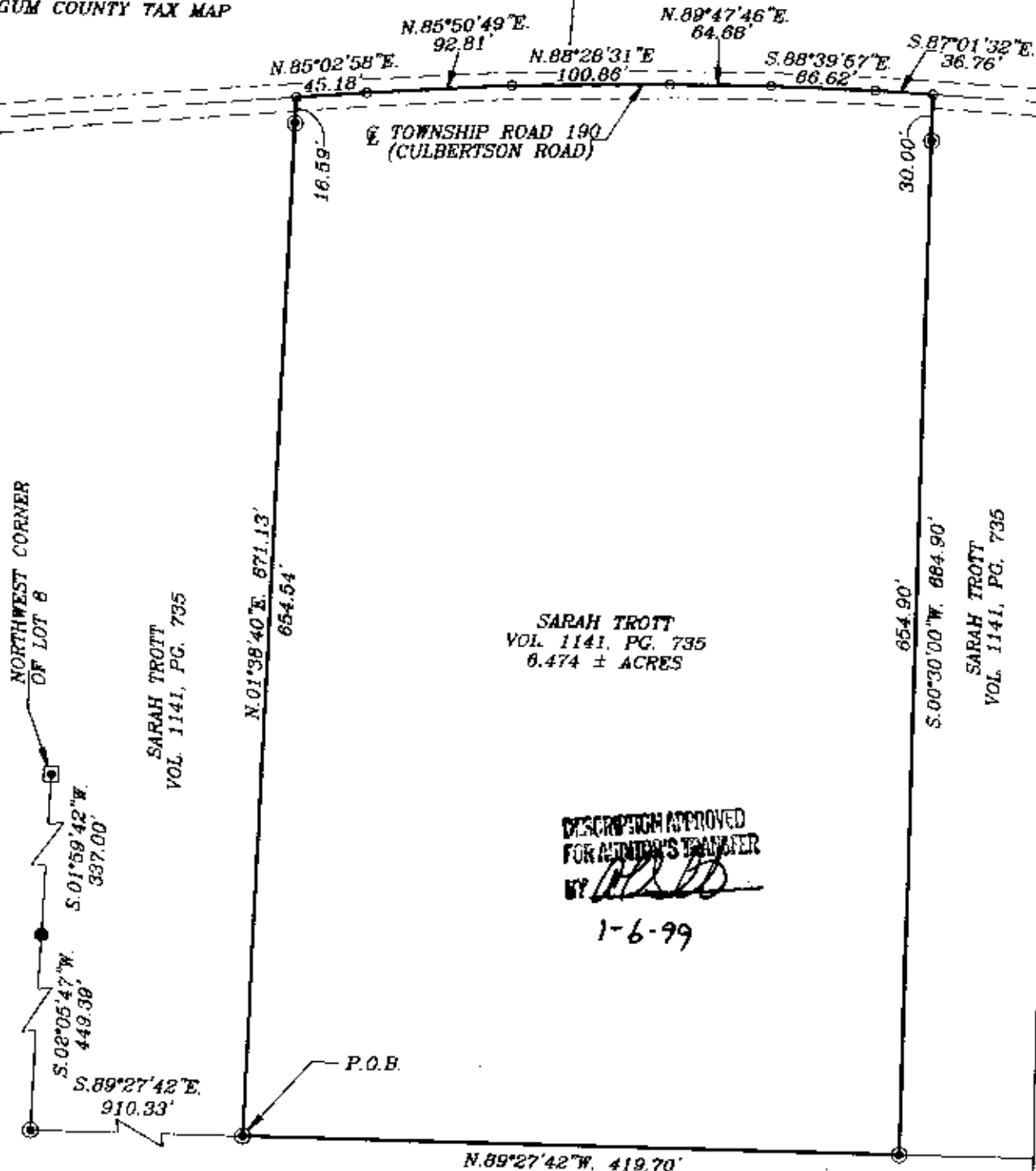
