COMMENCING AT AN EXISTING STONE AT THE NORTHWEST CORNER OF LOT NUMBER 8; THENCE NORTH 01 DEGREES 59 MINUTES 42 SECONDS EAST 481.81 FEET TO AN EXISTING IRON PIN (5/8 INCH REBAR);

THENCE SOUTH 88 DEGREES 09 MINUTES 53 SECONDS EAST 717.68 FEET TO AN IRON PIN SET, SAID IRON PIN BEING THE PLACE OF BEGINNING OF THE TRACT HEREIN INTENDED TO BE DESCRIBED;

THENCE SOUTH 88 DEGREES 09 MINUTES 53 SECONDS EAST 374.66 FEET ALONG THE NORTH LINE OF SARAH TROTT PROPERTY TO AN IRON PIN SET;
THENCE LEAVING SAID NORTH LINE SOUTH 03 DEGREES 34 MINUTES 12 SECONDS WEST 559.66 FEET TO A POINT IN THE CENTER OF TOWNSHIP ROAD 190 (CULBERTSON ROAD) PASSING AN IRON PIN SET AT 519.66 FEET;

THENCE SOUTH 88 DEGREES 28 MINUTES 32 SECONDS WEST 34.77 FEET TO A POINT IN THE CENTER OF THE SAID ROAD,

THENCE SOUTH 85 DEGREES 50 MINUTES 48 SECONDS WEST 92.81 FEET TO A POINT IN THE CENTER OF SAID ROAD;

THENCE SOUTH 85 DEGREES 03 MINUTES 00 SECONDS WEST 191.60 FEET TO A POINT IN THE CENTER OF SAID ROAD;

THENCE SOUTH 83 DEGREES 57 MINUTES 16 SECONDS WEST 63.82 FEET TO A POINT IN THE CENTER OF SAID ROAD;

THENCE LEAVING THE SAID ROAD, NORTH 03 DEGREES 59 MINUTES 55 SECONDS EAST 602.94 FEET TO THE PLACE OF BEGINNING, PASSING AN IRON PIN SET AT 30 FEET;

CONTAINING 5.010 MORE OR LESS ACRES, 4.06 ACRES IN LOT 9 AND 0.95 ACRES IN LOT 8, SUBJECT TO ALL LEGAL ROAD RIGHT-OF-WAY OF TOWNSHIP ROAD 190 (CULBERTSON ROAD).
