

DESCRIPTION OF SURVEY FOR DOUG CULBERTSON

JOB#1165-2

Situated in the State of Ohio, County of Muskingum, Township of Washington:

Being part of the Southeast Quarter of Section #2, Township #1, Range #7, of the US Military District, **being part of the D & S Culbertson property described in Deed Book Volume 928, Page 78 and Official Record Volume 1653, Page 341, of said county's deed records, known as Muskingum County Auditor's Parcel Number 70-15-02-27-000, and more particularly described as follows;**

Commencing at a Stone (found marked) at the Southeast corner of Section #2, also being a common corner for Sections #1, #9, & #10 of said Township and Range; **THENCE North 02 degrees 24 minutes 40 seconds East 1530.86 feet** along the common line for said Sections #1 & #2 to an iron pin (found) at a corner of said D & S Culbertson property described in Official Record Volume 1653, Page 341, also being the place of beginning of the property herein intended to be described;

- #1- **THENCE North 87 degrees 35 minutes 20 seconds West 172.34 feet** into Section #2 and along said D & S Culbertson property to an iron pin (found);
- #2- **THENCE South 15 degrees 46 minutes 40 seconds West 177.19 feet** continuing along said D & S Culbertson property to the center line of Culbertson Road (Township Road #190), passing an iron pin (found) at 160.29 feet;
- #3- **THENCE North 67 degrees 38 minutes 50 seconds West 65.08 feet** continuing along said D & S Culbertson property and road to the unmarked Southeast corner of the D & S Culbertson property recorded in Deed Book Volume 928, Page 78;
- #4- **THENCE along a curve to the left having a chord bearing North 79 degrees 58 minutes 00 seconds West 75.85 feet**, a radius of 177.72 feet, and arc length of 78.43 feet, continuing along a line of said D & S Culbertson property and road to an unmarked point;
- #5- **THENCE North 01 degrees 39 minutes 50 seconds West 136.22 feet** leaving said road and through said D & S Culbertson property to an iron pin (set), passing an iron pin (set) at 18.76 feet;
- #6- **THENCE North 33 degrees 32 minutes 30 seconds East 79.21 feet** continuing through said D & S Culbertson property to an iron pin (set);
- #7- **THENCE North 33 degrees 28 minutes 10 seconds West 120.64 feet** continuing through said D & S Culbertson property to an iron pin (found) at a corner of said D & S Culbertson property;
- #8- **THENCE South 87 degrees 35 minutes 20 seconds East 389.10 feet** along a line of said D & S Culbertson property to an iron pin (found) on the common line for Sections #1 & #2;
- #9- **THENCE South 02 degrees 24 minutes 40 seconds West 161.30 feet** along the common line for Sections #1 & #2 to the place of beginning, **containing 1.86 acres.**

The bearings within this description are based on State Plane Coordinate Grid derived from a Solar Observation (Local Hour Angle Method). Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness P.L.S.#6885).
