

DESCRIPTION OF SURVEY FOR JANE W EVERETT

Situated in the State of Ohio, County of Muskingum, Township of Washington:

Being part of the West Half, Northwest Quarter, Section 2 and Northeast Quarter of Section 3, Township 1, Range 7, of the US Military District, further **being part of** the Jane W Everett property recorded in **Official Record Volume 2321, Page 319** of said county's deed records, further being part of Muskingum County **Auditor's Parcel Numbers 70-15-03-02-000 and 70-15-02-04-000**, and more particularly described as follows;

Beginning at a stone (found) at the Northeast corner for said West Half of the Northwest Quarter of Section 2, further being the Northwest corner of Lot 3 of Culbertson Subdivision as described in Common Pleas Court Record 46, Page 580, associated with Journal Book 46;

- #1- **THENCE South 03 degrees 10 minutes 11 seconds West 631.57 feet** along the common line for said West Half of the Northwest Quarter of Section 2 and Culbertson Subdivision to an unmarked point in the roadbed of a private drive, passing and iron pin (found) at 611.57 feet being the common corner for the Lawrance J Swingle property recorded in Official Record Volume 2172, Page 190 and for the LaJoy Green property recorded in Official Record Volume 1907, Page 641;
- #2- **THENCE North 87 degrees 39 minutes 24 seconds West 2084.87 feet** crossing said Everett property and said West Half of Section 2, and into said Northeast Quarter of Section 3, to an iron pin (set) on a line of the State of Ohio property recorded in Deed Book Volume 1130, Page 775, passing an iron pin (set) at 670.00 feet;
- #3- **THENCE North 25 degrees 46 minutes 24 seconds East 474.42 feet** along a common line for said Everett and State of Ohio properties to an aluminum monument (found);
- #4- **THENCE South 88 degrees 51 minutes 00 seconds East 580.00 feet** continuing along said properties and crossing into said West Half of the Northwest Quarter of Section 2 to an aluminum monument (found);
- #5- **THENCE North 31 degrees 58 minutes 02 seconds East 196.01 feet** continuing along said properties to an aluminum monument (found) on the North line of said Section 2;
- #6- **THENCE South 88 degrees 17 minutes 48 seconds East 1228.64 feet** along said Section line to the place of beginning, containing 6.59 acres from Section 3 being part of Parcel Number 70-15-03-02-000 and 18.96 acres from Section 2 being part of Parcel Number 70-15-02-04-000, for a **Total of 25.55 acres**.

The bearings within this description are based on State Plane Coordinate Grid (Ohio South 1983) derived from GPS Observations. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness P.L.S.6885).

This description was written by Charles R.
