Situated in the State of Ohio, County of Muskingum, Township of Washington, bounded and described as follows:

Being a part of the Southeast Quarter of Section 3, Township 1 North, Range 7 West, United States Military Lands, and being more particularly described as follows:

Beginning for reference at an iron pin found at the southwest corner of the Southeast Quarter of Fractional Section 3;

THENCE along the west line of lands now owned by S.F. and C.R. Peterson (DR 955-248) North 02 degrees 21 minutes 59 seconds East for a distance of 203.66 feet to a point on the centerline of Culbertston Road (Twp. Rd. 190) and the principal place of beginning;

THENCE along the east line of lands now owned by J. and M. Michel (DR 983-202), S. Trott (DR 1141-735) and J. and L. Smith (DR 1151-793) North 02 degrees 21 minutes 59 seconds East for a distance of 2470.30 feet to an iron pin found, passing an iron pin set 30.00 feet and an iron pin found at 491.01, from which an iron pin found bears South 87 degrees 48 minutes 14 seconds East 10.21 feet;

THENCE along the south line of lands now owned by J. Everett (DR 550- ) South 86 degrees 56 minutes 12 seconds East for a distance of 2633.92 feet to an iron pin found;

THENCE South 02 degrees 35 minutes 33 seconds West for a distance of 319.70 feet to an iron pin found on the northeast corner of lands now owned by R.D. Wells (DR 112-195);

THENCE along said Wells' north line North 87 degrees 18 minutes 44 seconds West for a distance of 1314.12 feet to an iron pin found;

THENCE South 02 degrees 28 minutes 58 seconds West for a distance of 129.20 feet to the northeast corner of lands now owned by P.D.H Farms (DR 548-675);

THENCE along the north line of said P.D.H. Farms' lands North 87 degrees 52 minutes 49 seconds West for a distance of 594.00 feet to said P.D.H. Farms' northwest corner;

THENCE along the west line of said P.D.H. Farms' lands South 02 degrees 28 minutes 58 seconds West for a distance of 99.00 feet to a point on the south line of Fractional Section 3;

THENCE along said south line of Fractional Section 3 North 87 degrees 52 minutes 49 seconds

West for a distance of 467.77 feet to an iron pin found on said S.F. and C.R. Peterson's north line;

THENCE along said Peterson's north line the following six courses:

- 1) North 65 degrees 12 minutes 20 seconds West for a distance of 104.30 feet to a point;
- 2) North 57 degrees 50 minutes 23 seconds West for a distance of 52.64 feet to a point;
- 3) North 52 degrees 53 minutes 20 seconds West for a distance of 53.13 feet to a point;
- 4) North 37 degrees 49 minutes 59 seconds West for a distance of 53.66 feet to a point;
- 5) North 22 degrees 26 minutes 37 seconds West for a distance of 48.99 feet to a point;
- 6) North 17 degrees 20 minutes 57 seconds West for a distance of 26.71 feet to the principal place of beginning.

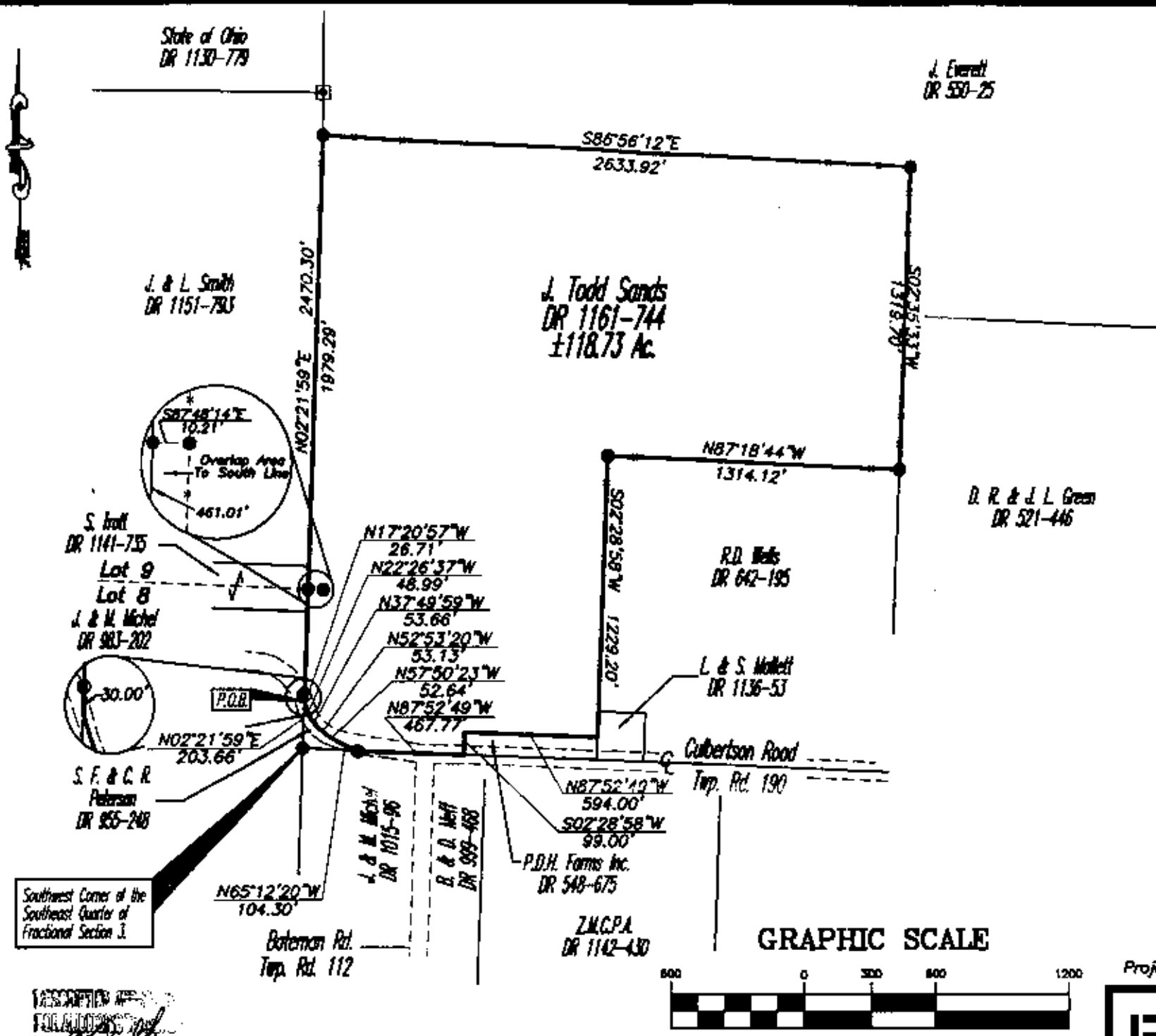

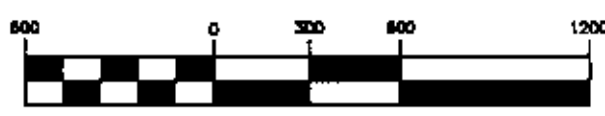
