Being a part of the Northeast Quarter of Section Nine (9), Township One (1), Range Seven (7) of the United States Military Lands and part of the Second Parcel of Deed Book 735, Page 163 owned by Robert T. Miles and Recorded in the Muskingum County Deed Records bounded and described as follows:

Commencing at a stone found at the northeast corner of said northeast quarter of section 9; thence N 87° 08' 34" W (the base of bearings for this description is State Plane Grid from a Solar Observation) along the north line of said quarter 1790.48 feet to a 2½ inch magnetized nail set in the center of Church Hill Road and passing through an iron pin set at 1764.48 feet; thence S 14° 01' 03" E along the center of said road 173.28 feet to a point; thence S 13° 54' 38" E along the center of said road 174.07 feet to a 2½ inch magnetized nail set at the true place of beginning; thence N 76° 05' 22" E 632.00 feet to an iron pin set and passing through an iron pin set at 22.00 feet; thence S 14° 14' 08" E 345.01 feet to an iron pin set; thence S 76° 05' 22" W 626.94 feet to a railroad spike set in the center of said Church Hill Road and passing through an iron pin set at 601.94 feet; thence along the center of said Church Hill Road and the east line of property owned by the Zanesville Muskingum County Port Authority the following 2 courses and distances:

1 - N 16° 21' 00" W 164.80 feet to a railroad spike set

2 - N 13° 54' 38" W 180.35 feet to the true place of beginning containing Five and no Hundredths (5.00) acres.

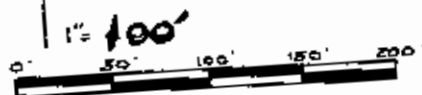
