Being a part of land located in the State of Ohio, Muskingum County, Washington Township, and part of east half of Section 8, part of Section 9 and part of the southeast quarter of Section 2, Township 1 North, Range 7 West, United States Military Lands. **Commencing** at an iron pin found at the southwest corner of the northwest quarter of Section 9, Township 1 North, Range 7 West;

thence along the east line of Section 8 South 03 degrees 00 minutes 42 seconds West 404.06 feet to an iron pin found, the **place of beginning** for this parcel;

thence through the Zanesville-Muskingum County Port Authority (OR 1142-426) the following five courses:

- 1. South 87 degrees 06 minutes 12 seconds West 296.24 feet to an iron pin set;
- 2. North 18 degrees 48 minutes 17 seconds West 1907.93 feet to an iron pin found;
  - 3. North 10 degrees 49 minutes 43 seconds West 695.09 feet to an iron pin found;
  - 4. North 20 degrees 06 minutes 28 seconds West 622.93 feet to an iron pin found;
- 5. North 20 degrees 06 minutes 28 seconds West 66.28 feet to a point in the centerline of Culbertson Road (TR 190), (40' right of way);

thence along the centerline of Culbertson Road (TR 190) (40' right of way) South 87 degrees 04 minutes 59 seconds East 534.81 feet to a point, being the northwest corner of A.J. & A.M. Schlater (DR 850-145);

thence leaving the centerline of Culbertson Road (TR 190) (40' right of way) and along the west line of A.J. & A.M. Schlater (DR 850-145) South 02 degrees 42 minutes 34 seconds West 15.00 feet to an iron pipe found disturbed;

thence continuing along the west line of A.J. & A.M. Schlater (DR 850-145) South 02 degrees 42 minutes 34 seconds West 489.03 feet to a point being the southwest corner of A.J. & A.M. Schlater (DR 850-145), an iron pipe found bearing South 15 degrees 28 minutes 02 seconds West 0.22 feet;

thence along the south lines of A.J. & A.M. Schlater (DR 850-145) and W.U. Clark (OR 1580-945) South 81 degrees 20 minutes 44 seconds East 900.30 feet to an iron pipe found, being the southeast corner of W.U. Clark (OR 1580-945) and the southwest corner of R. Green (OR 1087-158);

thence along the south line of R. Green (OR 1087-158) South 86 degrees 56 minutes 24 seconds East 708.11 feet to an iron pin found, being the southeast corner of R. Green (OR 1087-158);
