Commencing at a wood post (found) at the center of Section #9; thence N 86 11 30 E 1134.74 feet into the Northeast Quarter of Section #9 and along the common line for said Williams property and the Robert Miles property described in deed reference Deed Book Volume 1029, Page 576 to an iron pin (set), being the place of beginning for the property herein intended to be described;

- #1- thence N 86 11 30 E 599.54 feet continuing along the common line for said Williams and Miles properties to a point in the center of Church Hill Road (County Road #110), being a common corner for said Williams and Miles proparties and for the M.W. Stotts property described in deed reference Deed Book Volume 617, Page 112, passing an iron pin (set) at 556.06 feet, said point in the center of Church Hill Road located 3 feet South of the concrete rails of a bridge crossing a tributary of Little Salt Creek, and 14.35 feet South of the center of said bridge;
- #2- thence S 09 15 30 W 212.00 feet along the center of said road and common line for said Williams and Stotls properties to a point on the Quarter Section line between the Northeast and Southeast Quarters of Section #9, from which an iron pin (found) at the Southeast corner of the Northeast Quarter and Northeast corner of the Southeast Quarter bears for reference S 86 49 40 E 915.60 feet;
