Thence with the section line, common to Sec. 9 and Sec. 10, South 02 degrees 26 minutes 02 seconds West, 916.10 feet to a roof bolt found, being the principal place of beginning, passing a pipe found at 576.10 feet (referenced by a pipe found which bears, North 87 degrees 36 minutes 51 seconds West, 912.36) and a pipe found at 915.03 feet;

Thence continuing with said section line, also being the common line of the lands owned by J. Todd Sands (OR 1926-945) and the lands now owned by Jane W. Everett (OR 2321-319), thence South 02 degrees 26 minutes 02 seconds West, 360.12 feet to a pk nail set in the center of Adamsville Road (SR-93), passing an iron pin set at 315.12 feet, said pk nail is referenced by a pipe found which bears, North 61 degrees 05 minutes 29 seconds East, 103.58 feet:

Thence leaving said section line and going with the center of said Adamsville Road, South 82 degrees 33 minutes 24 seconds West, 48.53 feet to a pk nail set on the southeast corner of the lands of J. Todd Sands (DR 1080-15);

Thence leaving the center of said Adamsville Road and going with the common line of J. Todd Sands (DR 1080-15 and J. Todd Sands (OR 1926-945) lands the following two (2) courses:

- thence North 00 degrees 35 minutes 07 seconds East, 360.49 feet to a point, said point is referenced by a pipe found which bears, North 13 degrees 13 minutes 03 seconds East, 1.28 feet and a disturbed iron pin which bears, South 68 degrees 55 minutes 36 seconds East, 15.81 feet, passing a pipe found at 46.92 feet, 0.46 feet left;
- thence North 84 degrees 38 minutes 09 seconds East, 60.00 feet to the place of beginning, containing 0.445 acres more or less, subject to all legal highways and easements of record.

All iron pins set are 5/8 inch by 30 inch steel rebar with plastic identification caps marked MCPEEK PS8517.
