Commencing at a stone found at the Northwest corner of Section 10; Thence South $02^{\circ}24'50''$ West 613.24 feet to a stone found; Thence South $87^{\circ}29'10''$ East 843.22 feet to an iron pin found; Thence South $87^{\circ}23'40''$ East 1053.36 feet to an iron pin set the place of beginning passing iron pins found at 53.63 feet and 1019.26 feet; Thence South $87^{\circ}23'40''$ East 331.16 feet along Robert Bednarczuk Deed Volume 995, page 56, to an iron pin set; Thence along the split line of said Volume 1141, page 391, South $01^{\circ}49'29''$ West 173.04 feet to an iron pin set from which the South line of a 20.00 foot wide right of way for access to this property bears South $87^{\circ}23'40''$ East 362.06 feet to State Route 93; Thence North $87^{\circ}23'40''$ West along the South line of said 20.00 foot wide right of way 338.00 feet to an iron pin set; Thence North $4^{\circ}06'21''$ East 173.08 feet to the place of beginning containing 1.33 Acres more or less.

Except a 20.00 foot right of way along the South side.

Bearings are based on the West line of Section 10 bearing South $02^{\circ}24'50''$ West.

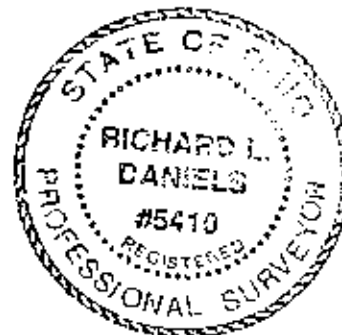
