Commencing at the unmarked common corner for the Northwest and Northeast Quarters of Section #10 and for the Southeast and Southwest Quarters of Section #1 of said Township and Range; **THENCE South 02 degrees 17 minutes 25 seconds West 1274.57 feet** along the common line for said Northeast and Northwest Quarters of said Section #10 to the unmarked common corner for said Shepler property and for the Timothy H & Trica A Rasor property recorded in Official Record Volume 1888, Page 356, also being the place of beginning for the property herein intended to be described, said corner being within the right of way for Adamsville Road (State Route #93);

- #1- THENCE South 02 degrees 17 minutes 25 seconds West 25.00 feet continuing along said Quarter Section Line and within said right of way to an unmarked point;
- #2- THENCE North 87 degrees 17 minutes 00 seconds West 252.46 feet into said Northwest Quarter and through said Shepler property to an iron pin (set), passing the centerline of Adamsville Road at 22.63 feet, and iron pin (set) at 57.46 feet;

- **#5- THENCE North 03 degrees 12 minutes 10 seconds East 150.37 feet** along the common line for said Shepler properties to an iron pin (found) at a common corner for said Shepler and Rasor properties;
- #6- THENCE South 87 degrees 17 minutes 00 seconds East 1515.61 feet along said Shepler and Rasor properties to the place of beginning, passing an iron pin (found) at 1459.29 feet and the centerline of Adamsville Road at 1493.30 feet containing 4.5 acres, of which 0.03 acres are within the right of way for Adamsville Road.
