Situated in the County of Muskingum, in the State of Ohio, and in the Township of Washington, and bounded and described as follows:

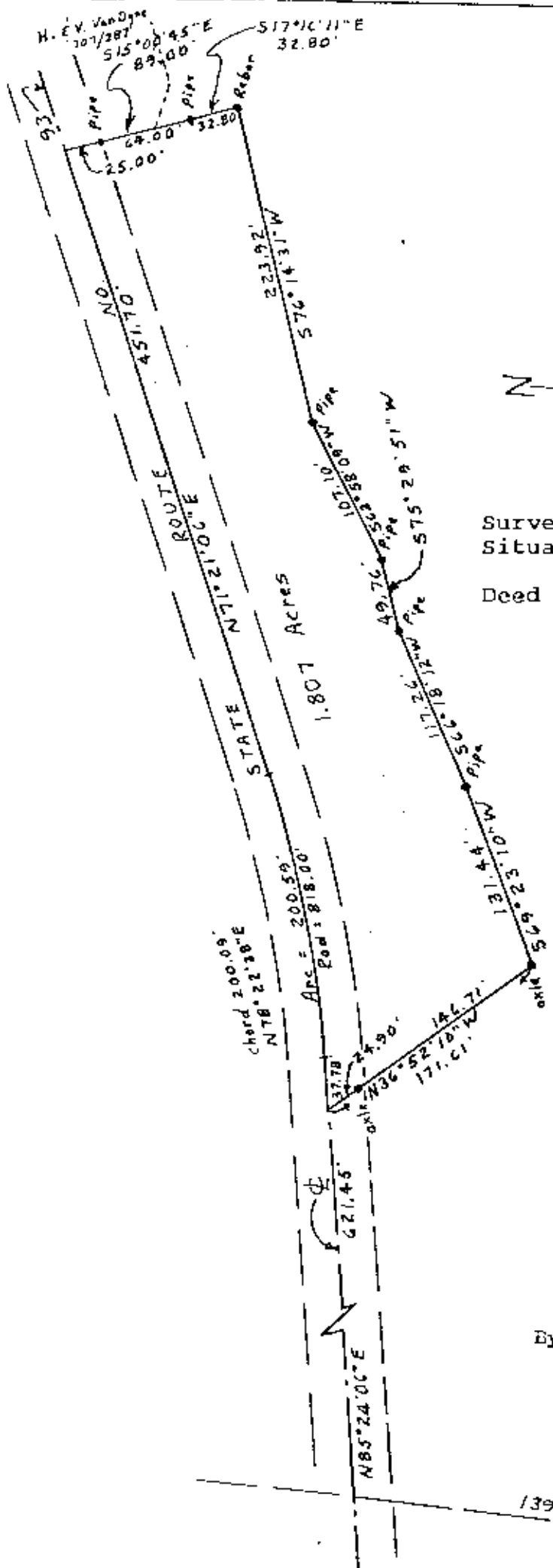
Being a part of the Southwest Quarter of Section 10, Township 1, Range 7, and more particularly described as follows, to-wit:

Commencing, for reference, at the Southwest corner of the said Southwest Quarter of Section 10; thence North 05 degrees 29 minutes 23 seconds East 1399.35 feet along the west line of the said Southwest Quarter to a point in the center of State Route No. 93; thence North 85 degrees 24 minutes 06 seconds East 621.45 feet to a point in the center of said road, said point being the Place of Beginning of the premises herein intended to be conveyed; thence continuing North 85 degrees 24 minutes 06 seconds East 37.78 feet to a point in the center of said road; thence along the center of said road on a curve to the left having a radius of 818.00 feet a distance of 200.59 feet (chord bears North 78 degrees 22 minutes 38 seconds East 200.09 feet); thence North 71 degrees 21 minutes 06 seconds East along the center of said road 451.70 feet; thence South 15 degrees 00 minutes 45 seconds East along the westerly line of a tract owned by H. A. and V. M. VanDyne as recorded in Deed Book 707, Page 287 of the Muskingum County Deed Records a distance of 89.00 feet to an iron pipe set, passing through an iron pin set at 25.00 feet; thence South 17 degrees 16 minutes 11 seconds East 32.80 feet to an iron pin (rebar) set; thence South 76 degrees 14 minutes 31 seconds West 223.92 feet to an iron pipe set; thence South 62 degrees 58 minutes 09 seconds West 107.10 feet to an iron pipe set; thence South 75 degrees 29 minutes 51 seconds West 49.76 feet to an iron pipe set; thence South 66 degrees 18 minutes 12 seconds West 117.26 feet to an iron pipe set; thence South 69 degrees 23 minutes 10 seconds West 131.44 feet to an iron pin (axle); thence North 36 degrees 52 minutes 10 seconds West 171.61 feet to the Place of Beginning, passing through an existing iron pin (axle) at 146.71 feet, and containing 1.807 acre, more or less, subject to all legal highways and easements of record.
