> Kevin A. Bunting DR 1058-417 +/- 88.251 Acres

Situated in the State of Ohio, County of Muskingum, Township of Washington, being part of the southeast quarter of Section 1, T1, R7 and being a part of the lands now owned by Kevin A. Bunting (DR 1058-417) and more particularly described as follows.

Beginning at a stone found at the southeast corner of Section 1, being on the common line that separates Washington and Perry Townships, also being the northeast corner of the lands now owned by Cameron Legacy, LLC (OR 2763-42), thence with the north line of said Cameron Legacy, LLC's lands, also being the common line of Sections 1 & 10, N 88°08'01" W a distance of 1964.91 feet to an iron pin set on the southeast corner of the lands now owned by Earl A. West & Mona J. West (DR 975-113);

thence leaving the common line of said Sections 1 & 10 and going with the common line of said Bunting/West the following two (2) courses:

- 1. N 01°37'17" E a distance of 148.97 feet to a pipe found, passing a pipe found at 15.82 feet;
- 2. N 88°05'25" W a distance of 237.91 feet to a iron pin set on the southeast corner of the lands now owned by Walter E. Sipos (DR 639-66);

thence with the common line of said Bunting/Sipos the following two (2) courses:

- N 01°54'35" E a distance of 91.53 feet to an iron pin set;
 N 88°05'25" W a distance of 368.67 feet to a point in the center of Adamsville Road (SR-93), passing an iron pin set at 340.06 feet;

thence with the center of said Adamsville Road the following nine (9) courses:

- 1. N 20°48'07" E, a distance of 178.40 feet to a point;
- 2. N 20°33'56" E, a distance of 380.15 feet to a point;
- 3. thence with a curve turning to the right with an arc length of 183.48 feet, with a radius of 783.68 feet, with a chord bearing of N 26°43'03" E, a distance of 183.06 feet to a point;
- 4. N32°53'49"E, a distance of 185.66 feet to a point;
- 5. N23°16'04"E, a distance of 59.33 feet to a point;
- 6. N16°12'22"E, a distance of 230.45 feet to a point;
 7. thence with a curve turning to the right with an arc length of 245.46 feet, with a radius of 679.26 feet, with a chord bearing of N 23°25'01" E a distance of 244.13 feet to a point;
- 8. thence with a compound curve turning to the right with an arc length of 393.34 feet, with a radius of 2098.09 feet, with a chord bearing of N 37°21'32" E a distance of 392.76 feet to a
- 9. thence with a compound curve turning to the right with an arc length of 282.35 feet, with a radius of 728.12 feet, with a chord bearing of N 53°38'58" E a distance of 280.59 feet to a

thence leaving the center of said Adamsville Road and going with the northerly line of said Bunting's
