COMMENCING AT AN EXISTING IRON PIN (5/8" REBAR) AT THE SOUTHEAST CORNER OF LOT 6 WALNUT HILL SUBDIVISION;

THENCE WITH THE EAST LINE OF SAID LOT 6, NORTH 16 DEGREES 23 MINUTES 56 SECONDS WEST 283.41 FEET TO AN IRON PIN SET, SAID IRON PIN SET BEING THE PLACE OF BEGINNING FOR THE TRACT HEREIN INTENDED TO BE DESCRIBED;

THENCE TRAVERSING THROUGH LOT 6 WITH THE NORTH LINE OF A TRACT CONVEYED TO M.L. AND L.F. MCCLELLAN (VOLUME 1716, PAGE 728 OF THE MUSKINGUM COUNTY DEED RECORDS), NORTH 65 DEGREES 53 MINUTES 56 SECONDS WEST 274.68 TO AN IRON PIN SET;

THENCE WITH THE WEST LINE OF LOT 6, NORTH 27 DEGREES 51 MINUTES 11 SECONDS EAST 153.17 FEET TO AN IRON PIN SET;

THENCE WITH THE NORTH LINE OF LOT 6 AND THE SOUTH LINE OF A TRACT CONVEYED TO P.B. MCELFRISH (VOLUME 1512, PAGE 734), SOUTH 65 DEGREES 53 MINUTES 56 SECONDS EAST 134.12 FEET TO AN IRON PIN SET;

THENCE WITH THE EAST LINE OF LOT 6 AND THE WEST LINE OF A TRACT CONVEYED TO BROWNING-FERRIS INDUSTRY OF OHIO, INC. (VOLUME 1007, PAGE 93), SOUTH 16 DEGREES 23 MINUTES 56 SECONDS EAST 201.00 FEET TO THE PLACE OF BEGINNING;

CONTAINING 0.717 MORE OR LESS ACRES, SUBJECT TO ALL LEGAL ROAD RIGHT OF WAYS OF STATE ROUTE 666 (NORTH RIVER ROAD) AND ALL OTHER APPLICABLE EASEMENTS.



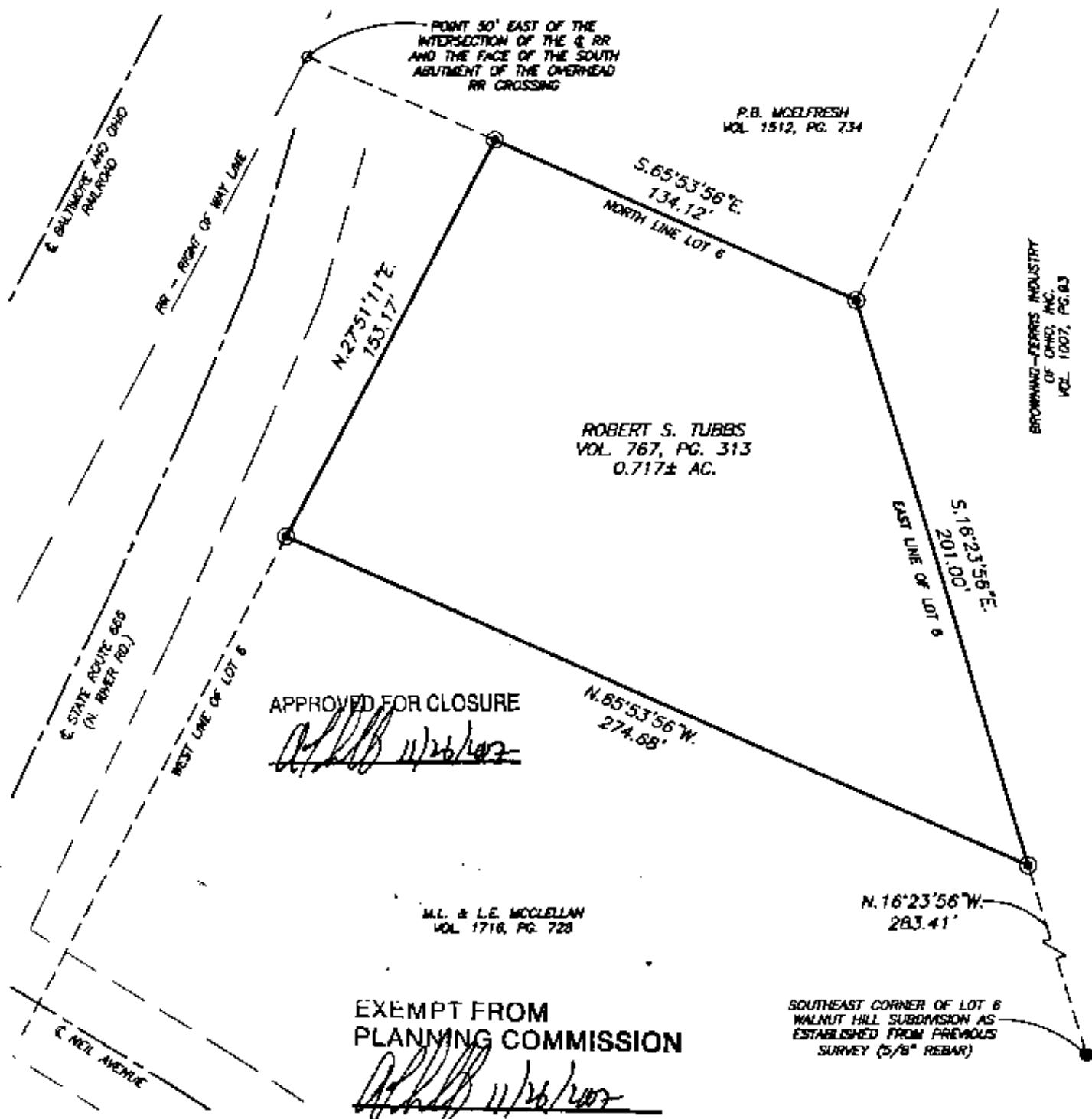
