

SITUATED IN THE STATE OF OHIO, COUNTY OF MUSKINGUM, TOWNSHIP OF WASHINGTON, R-7 TWP, 1 QTR. TWP. 3, UNITED STATES MILITARY LANDS;

BEING A RESURVEY OF A PARCEL CONVEYED TO BONNIE LINSCOTT AS FOUND IN DEED VOLUME 1015, PAGE 452 OF THE MUSKINGUM COUNTY RECORDER'S OFFICE AND BRING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT A POINT ON THE EAST LINE OF LOT UNDERWOOD'S SUBDIVISION AS FOUND IN PLAT BOOK A-O, PAGE 55, POINT BEING THE NORTHEAST CORNER OF A PARCEL CONVEYED TO HAROLD AND JEANNE PENN AS FOUND IN DEED VOLUME 412, PAGE 162, POINT BEING MARKEO BY A RAILROAD TIE:

THENCE WITH THE NORTH LINE OF THE PENN PARCEL N 74° 49'57" W 416.51 FEET TO A CONCRETE POST AND BEING THE PRINCIPLE PLACE OF BEGINNING OF THE TRACT HEREIN TO BE DESCRIBED, PASSING OVER AN IRON PIN FOUND AT 260.70 FEET:

THENCE CONTINUING WITH THE NORTH LINE OF THE PENN PARCEL N 74° 49'57" W 160.30 FEET TO AN IRON PIN FOUND:

THENCE CONTINUING WITH THE PENN PARCEL N 16° 03'12" E 349.79 FEET TO AN IRON PIN FOUND ON THE SOUTHERLY RIGHT-OF-WAY OF OLD ADAMSVILLE ROAD {COUNTY ROAD #694}:

THENCE CONTINUING WITH THE SOUTHERLY RIGHT-OF-WAY LINE OF OLD ADAMSVILLE ROAD S $62^{\circ}22^{\circ}07$ " E 158.16 FEET TO AN IRON PIN FOUND, POINT BEING THE NORTHWESTERLY CORNER OF A PARCEL CONVEYED TO R.DOUGLAS & BRENDA J.HOBSON IN DEED VOLUME 1061, PAGE 345 OF THE MUSKINGUM COUNTY RECORDER'S OFFICE:

THENCE CONTINUING WITH THE WEST LINE OF THE HOBSON PARCEL S 15° 05' 01" W 315.61 FEET TO THE PLACE OF BEGINNING. THE TRACT AS SURVEYED CONTAINS 1.2028 ACRES, MORE OR LESS, SUBJECT TO ALL LEGAL EASEMENTS OF RECORD.

THE BEARINGS OF THE ABOVE DESCRIED PARCEL ARE BASED ON THE WEST LINE OF THE 0.96 ACRE PARCEL CONVEYED TO R.DOUGLAS & BRENDA J.HOBSON AS BEING S 15° 05'01" W.
