Bearings are based on the South line of Muskingum Mining Lot 12 bearing South $89^{\circ} 57' 50''$ West.

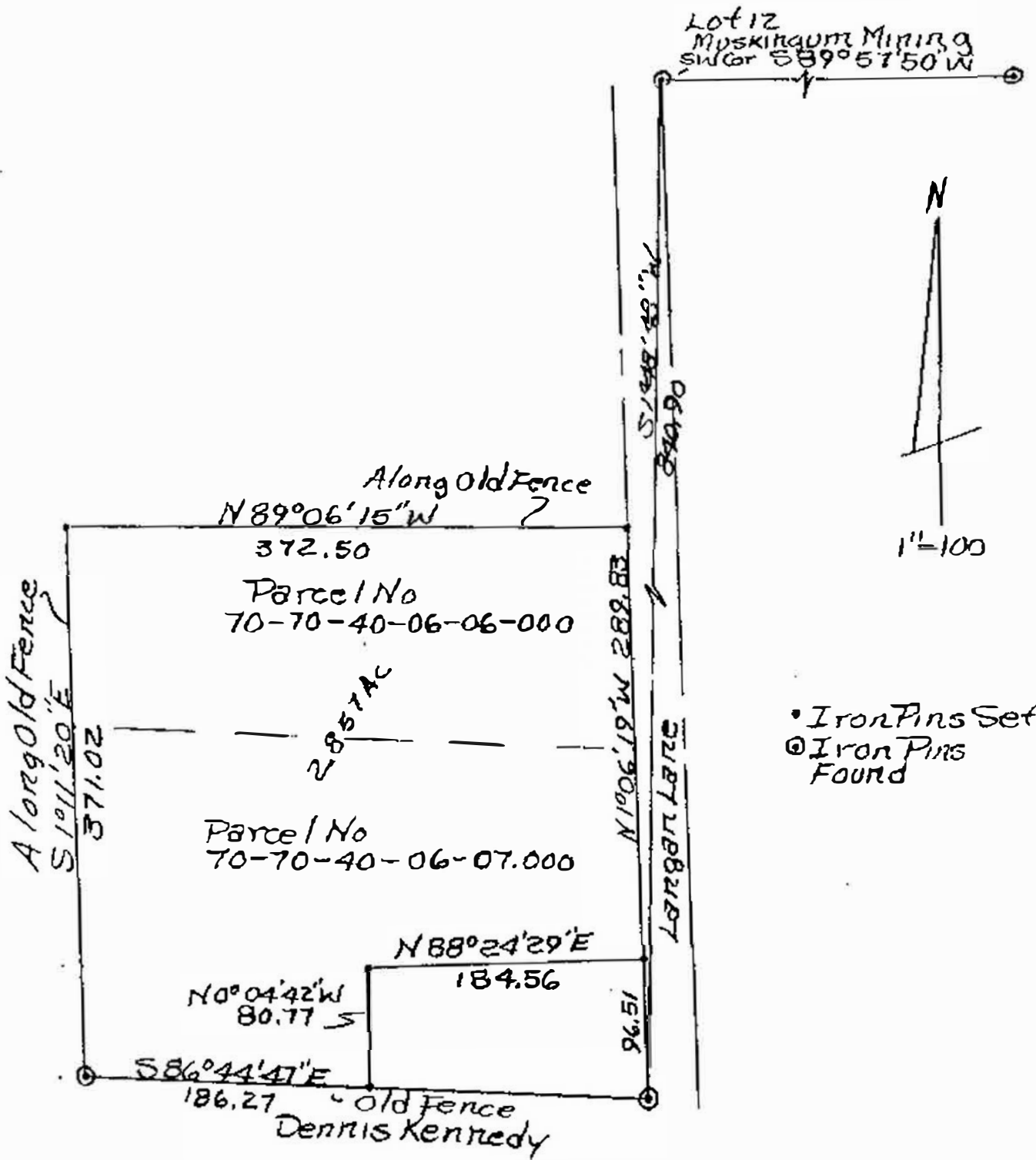
