

### Survey for The County of Muskingum

Being a part of land located in the State of Ohio, County of Muskingum, Washington Township, part of quarter township 3, Township 1 North, Range 7 West, United States Military Lands, and Wayne Township, part of Section 4, Township 12 North, Range 13 West, Congress Lands East of the Scioto River. Being part of the lands conveyed to The County of Muskingum, Ohio in Deed Record 1135, page 467 tract 1, tract 2, tract 3, tract 5, and tract 6, and Deed Record 2233-261, bounded and described as follows:

Commencing at an iron pin found at the northwest corner of Lot 7 of McBride's Addition (Replat Book 1, page 255);

thence along the east line of a vacated 50' wide public street and along the west lines of Lot 7, Lot 9, Lot 11, and Lot 13 South 10 degrees 56 minutes 27 seconds East 250.00 feet to an iron pin set at the northwest corner of Lot 15, the **place of beginning** for this parcel;

thence leaving the east line of said public street and through The County of Muskingum (Deed Record 1135, page 467 tract 1, tract 2, tract 3, tract 5, and tract 6, and Deed Record 2233-261) the following 22 courses:

1. Along the north line of Lot 15 North 77 degrees 34 minutes 08 seconds East 70.52 feet to an iron pin set;
2. Leaving the north line of Lot 15 South 32 degrees 13 minutes 19 seconds East 65.54 feet to an iron pin set;

22. North 79 degrees 03 minutes 33 seconds East 170.00 feet to the place of beginning containing 6.16 acres, more or less.
