COMMENCING AT AN EXISTING CONCRETE MONUMENT AT THE NORTHEAST CORNER OF LOT 53 OF THE WILLIAM BATEMAN ADDITION (PLAT BOOK 5, PAGE 74);

THENCE WITH THE WEST LINE OF EASTLYND ACRES (PLAT BOOK 10, PAGE 13), SOUTH 16 DEGREES 56 MINUTES 06 SECONDS EAST 782.69 FEET TO AN IRON PIN SET, SAID IRON PIN BEING THE PLACE OF BEGINNING OF THE TRACT HEREIN INTENDED TO BE DESCRIBED;

THENCE CONTINUING WITH THE SAID WEST LINE THE FOLLOWING TWO BEARINGS AND DISTANCES:

1. SOUTH 16 DEGREES 56 MINUTES 06 SECONDS EAST 19.59 FEET TO AN EXISTING ANGLE IRON;
2. SOUTH 17 DEGREES 37 MINUTES 36 SECONDS EAST 110.68 FEET TO AN IRON PIN SET;

THENCE TRAVERSING INTO THE SAID GREENLAWN ESTATES TRACT THE FOLLOWING THREE BEARINGS AND DISTANCES:

1. SOUTH 75 DEGREES 20 MINUTES 57 SECONDS WEST 288.13 FEET TO AN IRON PIN SET;
2. NORTH 17 DEGREES 57 MINUTES 35 SECONDS EAST 155.68 FEET TO A POINT;
3. NORTH 75 DEGREES 38 MINUTES 54 SECONDS EAST 197.71 FEET TO THE PLACE OF BEGINNING, PASSING AN IRON PIN SET AT 26.06 FEET;

CONTAINING 0.729 MORE OR LESS ACRES, SUBJECT TO ALL APPLICABLE EASEMENTS.

NOT TO BE USED AS A SEPARATE BUILDING SITE OR TRANSFERRED AS AN INDEPENDENT PARCEL IN THE FUTURE WITHOUT PLANNING COMMISSION APPROVAL IN ACCORDANCE WITH APPLICABLE SUBDIVISION REGULATIONS.
