Commeucing at a stoue found at the Southwest Corner of the Northwest Quarter of the Northwest Quarter of Quartet Township 4, Township 1, Range 7; thence south 89 degrees 22 minutes 34 seconds east 1194.54 feet to an iron pin and the true place of beginning of the premises herein intended to be described; thence north 0 degrees 37 minutes 26 seconds east 75.30 feet to an iron pin; thence north 50 degrees 06 minutes 13 seconds east 299.33 feet to an iron pin; thence north 48 degrees 43 minutes 14 seconds east 189.97 feet to an iron pin; thence north 61 degrees 36 minutes 35 seconds east 308.49 feet to an iron pin; thence south 78 degrees 26 minutes 28 seconds east 220.37 feet to a point in the center of State Route #93 (Adamsville Road); thence along said centerline south 11 degrees 33 minutes 32 seconds west 89.40 feet to a point; thence leaving said centerline and along the north line of a 1.596 acre parcel conveyed to Gerald E.
