Thence ,(by deed), South 61 degrees 12 minutes 14 seconds West, 438.24 feet to a iron pin on the south line of Gilbert Station Road, and the northeast corner of presently owned by Mark S. and Mary Lou Mann,(DR 1029-429);

Thence along the south line of said road, (by deed), North 41 degrees 00 minutes 56 seconds West, 517.23 feet to an iron pin found on the northwest corner of lands presently owned by David M. and Elizabeth Ann Mann, (OR 1732-80);

Thence along the west line of said Mann lands, South 45 degrees 01 minutes 54 seconds West, 168.23 feet to an iron pipe found, on the southwest corner of said Mann lands, and the principal place of beginning;

Thence along the south line of said Mann lands, South 44 degrees 55 minutes 53 seconds East, 150.10 feet to an iron pipe found on the west line of lands presently owned by Mark S. and Mary Lou Mann, (DR 1029-529);

Thence along the west line of said Mann lands, South 44 degrees 57 minutes 34 seconds West, 134.70 feet to the low water mark of the Muskingum River, passing an iron pipe found at 111.70 feet;

Thence along the low water mark of the Muskingum River, North 45 degrees 35 minutes 10 seconds West, 150.02 feet to a point on the east line of lands presently owned by Robert F. And Barbara Berry,(DR 1028-218);
