Surber, Deed Book 2520, Page 670 south 20 degrees 13 minutes 36 seconds west 84.78 feet to a concrete monument found; thence south 24 degrees 50 minutes 36 seconds west 70.0 feet to an iron pin set; thence along the north line of Mary Ann Lingel and Terry L. 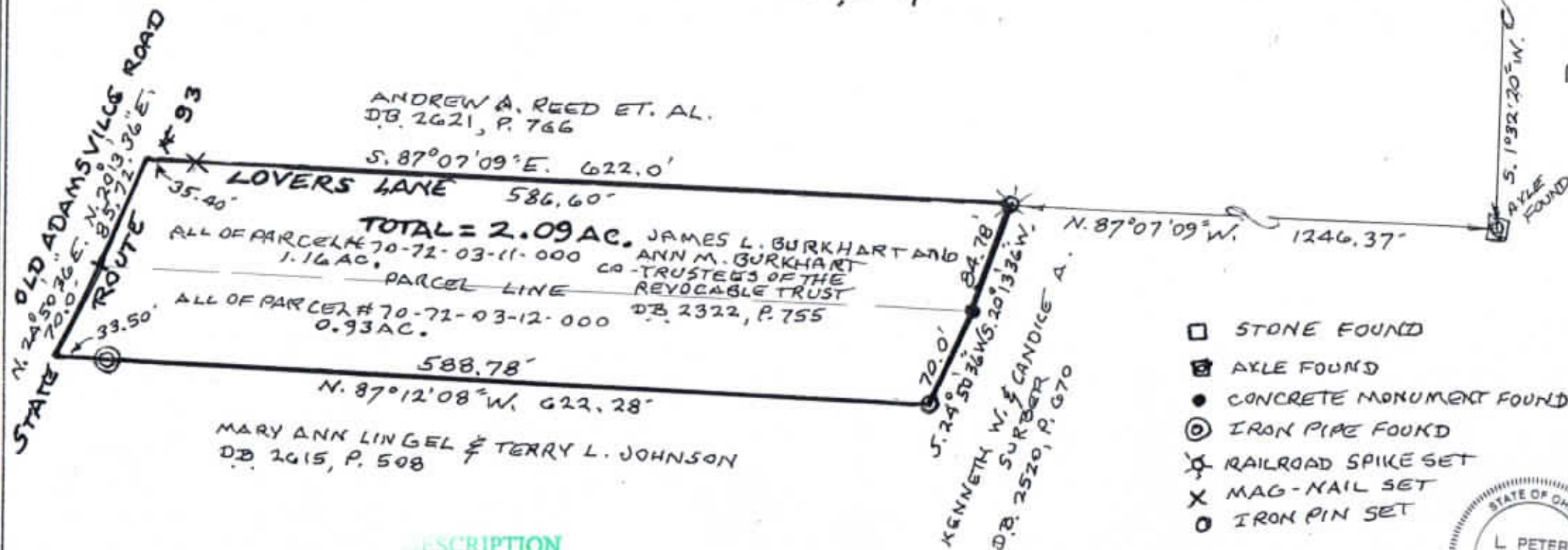
