Situated in the State of Ohio, county of Muskingum and Township of Washington.

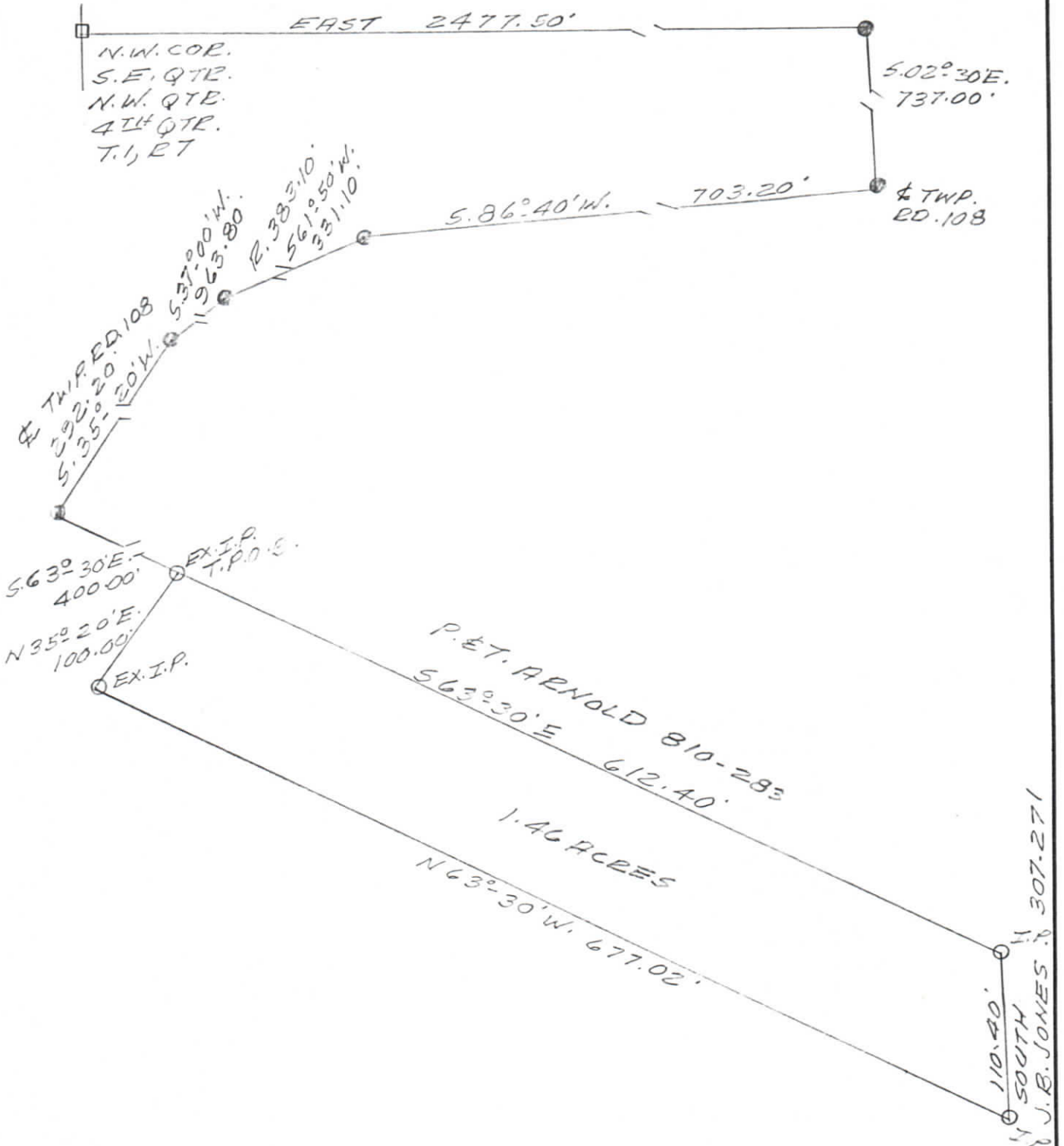
Being a part of the north half of quarter township 4, township 1, range 7, bounded and described as follows:

Commencing at the northwest corner of the southeast quarter of the northwest quarter of the said fourth quarter said commencing point also being the northwest corner of an eighty eight and thirty six (88.36) acre tract of land conveyed to John A. Keener from Harper by sheriff by deed dated February 21, 1895 in deed book 107, page 608 of the deed records of said county; thence east a distance of 2477.50 feet to a point which is the northwest corner of a twelve acre tract conveyed to Orriell M. Varner from John A. Keener by deed dated February 23, 1932 and recorded in deed book 244, page 70 of the deed records of said county; thence south 02 degrees 30 minutes east along the westerly line of said twelve acre tract a distance of 737.00 feet to a point in the center line of township road No. 108; thence south 86 degrees 40 minutes west along said centerline a distance of 703.20 feet to a point; thence on a curve to the left having a radius of 383.10 feet (the chord of which bears south 61 degrees 50 minutes west a chord distance of 331.10 feet to a point; thence south 37 degrees 00 minutes west along said centerline a distance of 963.80 feet to a point; thence south 35 degrees 20 minutes west along said centerline a distance of 292.20 feet to a point; thence south 63 degrees 30 minutes east along the northerly line of lands now or formerly owned by P. and T. Arnold and recorded in deed book 810, 283 of the deed records of said county a distance of 400.30 feet to an existing iron pin at the true place of beginning for the parcel herein intended to be described; thence continuing south 63 degrees 30 minutes east along said Arnold southerly line a distance of 612.40 feet to an existing iron pin; thence south along the westerly line of lands now or formerly owned by J.B. Jones and recorded in deed book 307, page 271 of the deed records of said county; a distance of 110.40 feet to an iron pin; thence north 63 degrees 30 minutes west a distance of 677.02 feet to an existing iron pin; thence north 35 degrees 20 minutes east along said Arnold easterly line a distance of 100.00 feet to the true place of beginning containing One and Fourty Six (1.46) hundredths acres more or less.
