Being a part of Quarter Township 4, Township 1, Range 7 bounded and described as follows:

Commencing at an iron pin found at the southeast corner of Lot 6 in Reed Acres; thence south 5 degrees 23 minutes 10 seconds west 25.0 feet to a point in Boggs Road; thence along said road north 87 degrees 18 minutes 40 seconds east 523.33 feet to a point; thence leaving said road south 5 degrees 08 minutes 20 seconds west 847.41 feet to a concrete filled 6 inch casing and the true place of beginning of the premises herein intended to be described; thence south 87 degrees 34 minutes east 309.35 feet to an iron pipe found; thence south 6 degrees 54 minutes 35 seconds west 644.23 feet to an iron pin placed on the north right of way line of Interstate #70; thence along said right of way line south 86 degrees 15 minutes 55 seconds west 292.60 feet to an iron pin placed; thence north 5 degrees 08 minutes 20 seconds east 674.46 feet to the true place of beginning, containing four and fifty-two hundredths (4.52) acres more or less.

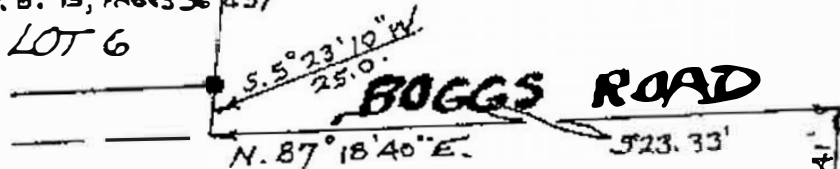
