Being a part of Quarter Township 4, Township 1, Range 7 bounded and described as follows:

Beginning at a nail found at the intersection of the centerline of Jackson Road and the centerline of Interstate #70 as recorded in Plat Book 10, Page 58; thence along the center of Interstate #70 north 70 degrees 39 minutes 51 seconds east 1613.72 feet to a point; thence south 1 degree 31 minutes 25 seconds east 883.51 feet to a point in the center of State Route #40; thence along said centerline south 64 degrees 57 minutes 14 seconds west 399.33 feet to a point; thence south 87 degrees 35 minutes 31 seconds west 141.27 feet to an iron pin found; thence north 2 degrees 33 minutes 54 seconds west 123.74 feet to an iron pin; thence south 87 degrees 35 minutes 11 seconds west 681.62 feet to an iron pin; thence south 2 degrees 24 minutes 25 seconds east 5.75 feet to an iron pin; thence north 58 degrees 55 minutes 19 seconds west 453.54 feet to a point in the center of Jackson Road; thence along said centerline on a curve to the left having a radius of 318.31 feet an arc length of 22.45 feet (the chord of which bears north 10 degrees 49 minutes 07 seconds east 22.45 feet) to a point; thence continuing along said centerline north 8 degrees 47 minutes 51 seconds east 180.84 feet to the place of beginning, containing twenty-three and ninety-eight hundredths (23.98) acres more or less.

Subject to the easements of Jackson Road, Interstate #70 and State Route #40.

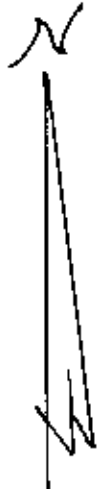
