

## DESCRIPTION OF SURVEY FOR JOHN &amp; HELEN TOMPKINS JOB#1274-2

Situated in the State of Ohio, County of Muskingum, Township of Washington:

Being part of Quarter Township #4, Township #1, Range #7, of the US Military District, **being part of** the John & Helen Tompkins property recorded in Official Record Volume 1717, Page 795 of said county's deed records, known as Muskingum County Auditor's Parcel Number 70-80-01-19-000, and more particularly described as follows;

Commencing at an axle (found) at the common corner for Lots #8 and #9 of Sunset Acres recorded in Plat Book 9, Page 55, also being the Northeast corner of a 4.53 acre parcel recorded in Deed Book Volume 439, Page 550, further being the Northeast corner of the J & C Hatfield property recorded in Deed Book Volume 1136, Page 810; **THENCE South 34 degrees 32 minutes 00 seconds West 99.75 feet** along the common line for said Lot #9 and East Line of said 4.53 acre parcel and for said Hatfield property to an axle (found) at the common corner for said Tompkins and Hatfield properties, **THENCE North 65 degrees 15 minutes 10 seconds West 119.25 feet** along the common line for said Tompkins and Hatfield properties to an iron pin (set) at the place of beginning for the property herein intended to be described;

- #1- **THENCE South 55 degrees 38 minutes 00 seconds West 132.09 feet** crossing said Tompkins property to an iron pin (set) on the common line for said Tompkins property and for the J & H Tompkins property recorded in Deed Book Volume 458, Page 378;
- #2- **THENCE North 52 degrees 38 minutes 35 seconds West 226.50 feet** along the common line for said Tompkins properties to an unmarked point in Boggs Road (County Road #108), passing an axle (found) at 200.75 feet;
- #3- **THENCE North 57 degrees 51 minutes 25 seconds East 76.30 feet** along said road to an unmarked common corner for said Tompkins and Hatfield properties;
- #4- **THENCE South 65 degrees 15 minutes 10 seconds East 247.16 feet** along the common line for said Tompkins and Hatfield properties to the place of beginning, passing an axle (found) at 30.00 feet, **containing 0.51 acres.**

The bearings within this description are based on the West line of Lot #9 of Sunset Acres recorded in Plat Book 9, Page 55. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness P.L.S.6885).

This description was written by Charles R.
