

DESCRIPTION OF SURVEY FOR JOHN & HELEN TOMPKINS JOB#1274-1

Situated in the State of Ohio, County of Muskingum, Township of Washington:

Being part of Quarter Township #4, Township #1, Range #7, of the US Military District, **being part of** the John & Helen Tompkins property recorded in Official Record Volume 1717, Page 795 of said county's deed records, known as Muskingum County Auditor's Parcel Number **70-80-01-19-000**, and more particularly described as follows:

Commencing at an axle (found) at the common corner for Lots #8 and #9 of Sunset Acres recorded in Plat Book 9, Page 55, also being the Northeast corner of a 4.53 acre parcel recorded in Deed Book Volume 439, Page 550, further being the Northeast corner of the J & C Hatfield property recorded in Deed Book Volume 1136, Page 810; **THENCE South 34 degrees 32 minutes 00 seconds West 99.75 feet** along the common line for said Lot #9 and East Line of said 4.53 acre parcel and for said Hatfield property to an axle (found) at the common corner for said Tompkins and Hatfield properties, also being to the place of beginning for the property herein intended to be described;

- #1- **THENCE South 34 degrees 32 minutes 00 seconds West 84.25 feet** continuing along the East line of said 4.53 acre parcel and West line of said Lot #9, and the East line of said Tompkins property to an axle (found) at a common corner for said Lot #9 and the Ohio District Council property recorded in Deed Book Volume 311, Page 143;
- #2- **THENCE South 34 degrees 32 minutes 00 seconds West 67.40 feet** continuing along the East line of said 4.53 acre parcel and Tompkins property and the West line of the Ohio District Council property to an unmarked common corner for said Tompkins property and for the J & H Tompkins property recorded in Deed Book Volume 458, Page 378;
- #3- **THENCE North 52 degrees 38 minutes 35 seconds West 165.26 feet** along the common line for said Tompkins properties to an iron pin (set), passing an axle (found) at 0.27 feet;
- #4- **THENCE North 55 degrees 38 minutes 00 seconds East 132.09 feet** crossing said Tompkins property recorded in Official Record Volume 1717, Page 795 to an iron pin (set) on the common line for said Tompkins and Hatfield properties;
- #5- **THENCE South 65 degrees 15 minutes 10 seconds East 119.25 feet** along the common line for said Tompkins and Hatfield properties to the place of beginning, **containing 0.44 acres.**

The bearings within this description are based on the West line of Lot #9 of Sunset Acres recorded in Plat Book 9, Page 55. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness P.L.S.6885).
