Being a part of land located in the State of Ohio, County of Muskingum, Township of Washington, and being part of the fourth quarter Township, Township 1 North, Range 7 West, United States Military Lands, bounded and described as follows:

Beginning at an iron pin set 45.00 feet right of State Route 93 centerline station 28+29.38 as shown on right of way plans MUS-93-13.03, page 7 of 11, also being on the north line of K. Johnston (DR 1095-432);

thence along the north line of K. Johnston (DR 1095-432) North 77 degrees 26 minutes 47 seconds West 68.85 feet to a point on the east line of Pleasant Grove Board of Education (DR 270-298);

thence along the east line of Pleasant Grove Board of Education (DR 270-298) and M. Elmore (DR 657-195) North 04 degrees 03 minutes 13 seconds East 302.75 feet to a point;

thence leaving the east line of M. Elmore (DR 657-195) and along the centerline of Boggs Road (C.R. 108) North 49 degrees 34 minutes 36 seconds East 183.86 feet to a point;

thence leaving the centerline of Boggs Road (C.R. 108) and along a south line of M.J. Pollock (DR 1144-962) South 71 degrees 11 minutes 47 seconds East 67.98 feet to an iron pin set;

thence continuing along a south line of M.J. Pollock (DR 1144-962) South 71 degrees 11 minutes 47 seconds East 185.99 feet to an iron pin set;

thence continuing along a south line of M.J. Pollock (DR 1144-962) North 71 degrees 18 minutes 13 seconds East 205.26 feet to an iron pin set;

thence along the west line of M.J. Pollock (DR 1144-962) South 01 degrees 11 minutes 47 seconds East 540.54 feet to a stone found on the south line of Lot 5 of John C. Howard's Subdivision (DR 9-394), also being the north line of K. Johnston (DR 1095-432);

thence leaving the east line of M.J. Pollock (DR 1144-962) and along the north line of K. Johnston (DR 1095-432) North 77 degrees 26 minutes 47 seconds West 553.53 feet to the principle place of beginning, containing 5.97 acres, more or less.

Iron pins set are 5/8 inch rebar 30 inches long with identification caps (DADECO 56345). This legal description was prepared by Denis P. Swierz Reg. Surv. No. 8062, based on a field survey made in October 2000 by DADECO Engineering.



