bounded and described as follows:

Commencing at the southeast corner of said quarter
township 4; thence west along the south line of said
quarter township 4 a distance of 1862.5 feet to a point;
thence north 01 degrees 24 minutes east a distance of
2354.3 feet to a point in the centerline of county road
No. 42 said point is also the southeast corner of lands
now or formerly owned by Ralph J. and Mary L. Dosch
and recorded in deed book 549, page 858 of the deed
records of said county; thence south 84 degrees 43
minutes 50 seconds east along said centerline a distance
of 209.93 feet to a point; thence north 88 degrees 56
minutes 30 seconds east along said centerline a distance
of 192.51 feet to a point at the true place of beginning
for the parcel herein intended to be conveyed; thence
north 09 degrees 04 minutes 21 seconds west and leaving
said centerline a distance of 399.74 feet to an iron
pin and passing through an iron pin at 25.00 feet;
thence north 89 degrees 48 minutes 50 seconds east a
distance of 87.16 feet to an iron pin; thence south 11
degrees 03 minutes 26 seconds east a distance of 397.95
feet to a point in said centerline and passing through
an iron pin at 372.95 feet; thence south 84 degrees
43 minutes 40 seconds west along said centerline a
distance of 35.40 feet to a point; thence south 88 degrees
56 minutes 30 seconds west along said centerline a
distance of 65.21 feet to the true place of beginning,
containing Eighty Five (0.85) hundredths of an acre
more or less.

Subject to the easement of all legal highways.


