Beginning at an iron pin set at the southwest corner of Lot 19, said iron pin set is referenced by an iron pin found which bears South $58^{\circ} 05' 10''$ East 0.237 feet; thence North $12^{\circ} 59' 27''$ West 100.000 feet to an iron pin set at the northwest corner of Lot 17; thence North $78^{\circ} 33' 46''$ East 58.350 feet along the north line of Lot 17 to an iron pin set, said iron pin set is referenced by an iron pin found which bears North $45^{\circ} 03' 27''$ West 1.917 feet; thence 116.149 feet on a curve to the left having a radius of 749.100 feet, a delta of $08^{\circ} 53' 02''$ and a chord which bears South $44^{\circ} 58' 31''$ East 116.033 feet to an iron pin set on the south line of Lot 19, said iron pin set is reference by an iron pin found which bears North $77^{\circ} 00' 33''$ East 0.196 feet; thence South $77^{\circ} 00' 33''$ West 119.790 feet to the place of beginning.
