**THENCE** CONTINUING WITH THE SAID NORTH LOT LINE, SOUTH 87 DEGREES 52 MINUTES 18 SECONDS EAST 33.00 FEET TO AN EXISTING IRON PIN (5/8 INCH REBAR WITH BOUTWELL CAP) ON THE NORTH LINE OF LOT 2, PASSING THE NORTHEAST CORNER OF SAID LOT 1 AT 28.75 FEET;

**THENCE** LEAVING THE SAID NORTH LINE OF LOT 2 AND WITH THE WEST LINE OF A PARCEL CONVEYED TO JAMES L. DAVIS (O.R. 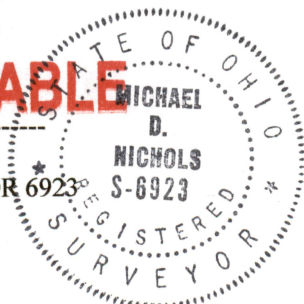
