**NEW LEGAL DESCRIPTION

Situated in the County of Muskingum, in the State of Ohio, and in the Township of Wayne, bounded and described as follows:

Being a new survey of what has been previously known as Lot Number Six (6) of an unrecorded (as yet, and unnamed) subdivision of tracts of land conveyed by deed of E. C. Heag, et al, to Wm. H. Koch, May 6, 1913. Said tracts are recorded in Deed Book No. 161, Page 555, of the Records of Muskingum County, Ohio, to which reference is hereby had and made. Said Lot is entirely in the Northwest Quarter of Section Four (4), Township Twelve (12), Range Thirteen (13), in the Northwest corner of said Wayne Township, Muskingum County, Ohio, and is more particularly bounded and described as follows:

Commencing for reference and tie at an existing iron pin (3/4 inch rod) at the Southeast corner of Lot Number Nine (9) of East Greenwood Terrace recorded in Plat Book 4, Page 101, of the Muskingum County Plat Records;

Thence run North 84 degrees 15 minutes 57 seconds East along the Northerly line of Wheeling Avenue (the Basis of Bearing for this survey as established by W. J. Biedenbach, Registered Surveyor No. 5718 on November 7, 1986) a distance of 232.55 feet to a point at the intersection of the West line of a 33 foot wide street;

Thence continue North 84 degrees 15 minutes 57 seconds East along the Northerly line of Wheeling Avenue a distance of 153.00 feet to a drill hole found in an existing concrete driveway;

Thence continue North 84 degrees 15 minutes 57 seconds East along the Northerly line of Wheeling Avenue a distance of 90.00 feet to the True Place of Beginning of the premises herein intended to be described, said point being the Southeasterly corner of the 0.339± acre tract conveyed to M. Maxwell (OR Book 1931, Page 664);

Thence from said True Place of Beginning run North 02 degrees 00 minutes 35 seconds West and on a line common with the Easterly line of said 0.339± acre tract a distance of 163.78 feet (record: 163.38 feet) to an existing iron pin with ID cap (Biedenbach RLS 5718), passing an iron pin (rebar) found at 20.00 feet;

Thence run North 68 degrees 29 minutes 40 seconds East (with and along the South line of an alley – by deed) a distance of 36.81 feet (record: 35.27 feet);

Thence run North 88 degrees 14 minutes 35 seconds East a distance of 11.13 feet to an existing old pipe having a mushroomed top;

Thence run South 01 degree 45 minutes 25 seconds East a distance of 173.09 feet (record: 172.72 feet) to an iron pin (3/8 inch rebar) set on the Northerly line of Wheeling Avenue;

Thence run South 84 degrees 15 minutes 57 seconds West along the Northerly line of Wheeling Avenue a distance of 45.16 feet to the True Place of Beginning, containing 0.177 Acre, more or less (Record: 0.17 Acre).


