and Township of Wayne.


Being a part of the northwest quarter of section 4,  
northwest half of township 12, range 13 bounded and described  
as follows:

Beginning at the northeast corner of the German  
Catholic Cemetery and recorded in plat book 4, page 85 of  
the plat records of said county; thence north 43 degrees 49  
minutes 25 seconds east along the southerly right of way  
line of Wheeling Avenue a distance of 214.50 feet to an  
iron pin; thence south 61 degrees 28 minutes 00 seconds  
east along the southerly line of lands now or formerly owned  
by Loyd E. Hanna and recorded in deed book 640, page 227 of  
the deed records of said county and along the southerly line  
of lands now or formerly owned by James C. Sims and recorded  
in deed book 648, page 183 of the deed records of said  
county and along the southerly line of lands now or formerly  
owned by Rufus Burton Dodd and recorded in deed book 344,  
page 198 of the deed records of said county a distance of  
379.50 feet to an iron pin and passing through an iron pin  
at 141.05 feet; thence south 10 degrees 27 minutes 59 seconds  
west a distance of 211.20 feet to an iron pin; thence north  
62 degrees 10 minutes 00 seconds west along the northerly  
line of lands now or formerly owned by Graves and sons and  
recorded in deed book 710, page 269 of the deed records of  
said county and along the northerly line of lands now or  
formerly owned by German Catholic Cemetery and recorded  
in plat book 4, page 85 of the plat records of said county  
a distance of 501.60 feet to the place of beginning and  
passing through an iron pin at 235.13 feet and 361.60 feet.  
containing Two and Six (2.06) hundredths acres more or less.
