

DESCRIPTION OF SURVEY FOR VICKY BORDER

Situated in the State of Ohio, County of Muskingum, Township of Wayne:

Being part of Lot #1 of a Plat of Lots made by order of the court of common pleas which is on file in the Clerk of Courts Record Book 35, Page 624, in Section #4, Township #12, Range #13, of the Congress Lands East of the Scioto River, **being all of the remaining** Immanuel Church of Christ property recorded in Deed Book Volume 1079, Page 413 of said county's deed records, known as Muskingum County Auditor's Parcel Number 73-03-07-15-000, and more particularly described as follows:

Commencing at an iron pin (found) at the Southwest corner of Lot #1 of said court ordered plat, also being on the North line of Chandlersville Road (State Route #146); **THENCE North 84 degrees 46 minutes 50 seconds East 68.82 feet** along the common line for said lot and road to an iron pin (found) at the Southeast corner of the Cecil Harper property recorded in Deed Book Volume 1155, Page 964 and being the place of beginning of the property herein intended to be described;

- #1- **THENCE North 02 degrees 02 minutes 40 seconds East 133.17 feet** leaving said road and through said Lot #1 and along a common line for said Church and Harper properties to an iron pin (found) at the Northeast corner of Parcel #1 of said Harper deed, also a corner of the Cecil Harper property recorded in Official Record Volume 1620, Page 930;
- #2- **THENCE North 02 degrees 02 minutes 40 seconds East 4.00 feet** along the East line of said Harper property to an iron pin (found) at the Northeast corner of said Harper property;
- #3- **THENCE South 89 degrees 51 minutes 40 seconds West 67.05 feet** along the North line of said Harper property to an iron pin (found) at the Northwest corner of said Harper property, also being on the West line of said Lot #1;
- #4- **THENCE North 02 degrees 33 minutes 00 seconds East 96.84 feet** along the West line of said Lot #1 to an iron pin (found) on a line of the H & J McMillan property recorded in Deed Book Volume 1103, Page 499;
- #5- **THENCE North 87 degrees 39 minutes 30 seconds East 132.00 feet** along a common line for said Church and McMillan properties to an iron pin (found) a common corner;
- #6- **THENCE South 02 degrees 02 minutes 40 seconds West 100.03 feet** along a common line for said Church and McMillan properties to an iron pipe (found) a common corner, also being the Northwest corner for the W & W Lackney property recorded in Deed Book Volume 1119, Page 199;
- #7- **THENCE South 02 degrees 02 minutes 40 seconds West 133.17 feet** along a common line for said Church and Lackney properties to an iron pin (found) at a common corner also being on the North line of said road and South line of said Lot #1;
- #8- **THENCE South 84 degrees 46 minutes 50 seconds West 66.00 feet** along the common line for said lot and road to the place of beginning, **containing 0.50 acres.**

The bearings within this description are based on State Plane Coordinate Grid derived from a Solar Observation (Local Hour Angle Method). Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness P.L.S.6885).





