Thence South 03° 04' 25" West, a distance of 389.93 feet to a capped rebar set on the southeasterly corner of the subject property and the northerly line of a 4.67 acre tract of land, now or formerly conveyed to Paul Construction Company, Inc., by a deed recorded in Official Record 2265, Page 85 of the records of the Muskingum County Recorder's Office, leaving said Sharon Ave, along the easterly line of the subject property and the westerly line of a 0.22 acre tract of land, now or formerly conveyed to Paul Construction Company, Inc., by a deed recorded in Official Record 2375, Page 308 of the records of the Muskingum County Recorder's Office, passing a 5/8 inch rebar found bent at 35.39 feet, and a capped "Linn Engineering" 5/8 inch rebar found at 163.28 feet, on the northwesterly corner of a 0.31 acre tract of land, now or formerly conveyed to Paul Construction Company, Inc., by a deed recorded in Official Record 2375, Page 308 (exception) of the records of the Muskingum County Recorder's Office;

Thence North 89° 56' 30" West, a distance of 60.00 feet to a 3/4 inch pipe found bent on the southwest corner of the subject property and the northerly line of a 4.67 acre tract of land, now or formerly conveyed to Paul Construction Company, Inc., by a deed recorded in Official Record 2265, Page 85 of the records of the Muskingum County Recorder's Office;

Thence North 03° 03' 45" East, a distance of 391.03 feet along the westerly line of the subject property and the easterly line of a 0.541 acre tract of land, now or formerly conveyed to Cody A and Maranda E Starner, by a deed recorded in Official Record 2914, Page 488 of the records of the Muskingum County Recorder's Office, to the centerline of Sharon Avenue, passing a capped rebar set at 361.03 feet;

Thence South 88° 53' 10" East, a distance of 52.43 feet along the centerline of said Sharon Avenue, returning to the PLACE OF BEGINNING and containing 0.54 acres, of which 0.04 acres are within the road right of way of Sharon Avenue.
