**LEGAL DESCRIPTION FOR

SITUATED IN THE STATE OF OHIO, COUNTY OF MUSKINGUM, TOWNSHIP OF WAYNE, AND BEING PART OF THE SOUTHEAST QUARTER OF FRACTIONAL SECTION #4, TOWNSHIP 12, RANGE 13, AND BEING THE REMAINDER OF THOSE LANDS INTENDED TO BE DESCRIBED IN DEED VOLUME 528, PAGE 684; BEING FURTHER BOUNDED AND DESCRIBED AS FOLLOWS:

BEGINNING AT AN IRON PIN FOUND AT THE SOUTHEAST CORNER OF LOT #58 OF SUNRAY FOURTH ADDITION, AS RECORDED IN PLAT BOOK 9, PAGE 7, THENCE, SOUTH 81 DEGREES - 43 MINUTES - 30 SECONDS EAST, 91.77 FEET TO AN IRON PIN FOUND; THENCE, SOUTH 07 DEGREES - 50 MINUTES - 59 SECONDS EAST, 100.44 FEET TO A POINT; THENCE, SOUTH 11 DEGREES - 34 MINUTES - 00 SECONDS EAST, 132.14 FEET TO AN IRON PIN FOUND; THENCE, NORTH 84 DEGREES - 18 MINUTES - 00 SECONDS WEST, 91.93 FEET TO AN IRON PIN FOUND AT THE SOUTHEAST CORNER OF LOT #57 OF SAID ADDITION; THENCE, NORTH 09 DEGREES - 38 MINUTES - 00 SECONDS WEST, 184.57 FEET TO AN IRON PIN FOUND AT THE NORTHEAST CORNER OF SAID LOT #57; THENCE, NORTH 84 DEGREES - 18 MINUTES - 00 SECONDS WEST, 13.63 FEET TO A POINT ON THE RIGHT-OF-WAY OF MOONLIGHT DRIVE; THENCE, ALONG A CURVE TO THE LEFT, HAVING A RADIUS OF 35.00 FEET, A LENGTH OF 55.63 FEET, THE CHORD OF WHICH BEARS NORTH 05 DEGREES - 37 MINUTES - 18 SECONDS EAST, 49.96 FEET TO THE POINT OF BEGINNING, AND CONTAINING 0.463 ACRES MORE OR LESS.

ALSO TO BE INCLUDED HEREIN IS THE FOLLOWING DESCRIBED EASEMENT FOR PURPOSES OF INGRESS AND EGRESS: COMMENCING AT THE NORTHEAST CORNER OF THE ABOVE-DESCRIBED PARCEL, THENCE, SOUTH 07 DEGREES - 50 MINUTES - 59 SECONDS EAST, 39.00 FEET TO THE TRUE POINT OF BEGINNING FOR THIS EASEMENT; THENCE, CONTINUING SOUTH 07 DEGREES - 50 MINUTES - 59 SECONDS EAST, 28.19 FEET TO A POINT; THENCE, NORTH 70 DEGREES - 13 MINUTES - 56 SECONDS WEST, 51.85 FEET TO A POINT; THENCE, NORTH 73 DEGREES - 18 MINUTES - 51 SECONDS WEST, 50.06 FEET TO A POINT ON MOONLIGHT DRIVE; THENCE, ALONG A CURVE TO THE LEFT HAVING A RADIUS OF 35.00 FEET, A LENGTH OF 25.61 FEET, THE CHORD OF WHICH BEARS NORTH 12 DEGREES - 34 MINUTES - 53 SECONDS EAST, 25.05 FEET TO A POINT; THENCE, SOUTH 73 DEGREES - 18 MINUTES - 51 SECONDS EAST, 52.53 FEET TO A POINT; THENCE, SOUTH 70 DEGREES - 13 MINUTES - 56 SECONDS EAST, 39.45 FEET TO THE POINT OF BEGINNING AND THE TERMINUS OF THIS EASEMENT, AND CONTAINING 0.0547 ACRES MORE OR LESS. 
