thence; South 67 degrees 48 minutes 12 seconds West 601.96 feet to a point,

thence; South 71 degrees 10 minutes 26 seconds West 29.93 feet to a point,

thence; along a curve to the left having a radius of 1612.27 feet, North 27 degrees 34 minutes 45 seconds West a chord length of 339.54 feet to a point,

thence; North 34 degrees 01 minutes 22 seconds West 1044.64 feet to an iron pin found, said point being the true point of beginning,

thence; continuing North 34 degrees 01 minutes 22 seconds West, along the north line of Mid-East Ohio Vocational School, Deedbook 557, Page 267, 292.01 feet to an iron pin found,

thence; continuing along the north line of Mid-East Ohio Vocational School, Deedbook 557, Page 267, North 34 degrees 01 minutes 22 seconds West, 83.26 feet to a 5/8 x 30-inch rebar set and capped M S Hill S-7536, hereafter referred to as iron pin set,

thence; continuing along the north line of Mid-East Ohio Vocational School, Deedbook 557, Page 267 and along the north line of Paul Weaver, Deedbook 517, Page 899, along a curve to the left having a radius of 672.61 feet, North 61 degrees 10 minutes 10 seconds West a chord length of 613.79 feet to an iron pin set,

thence; continuing along the north line of Paul Weaver, Deedbook 517, Page 899, North 88 degrees 18 minutes 59 seconds West, 389.28 feet to an iron pin set,

thence; continuing along the north line of Paul Weaver, Deedbook 517, Page 899, along a curve to the right having a radius of 773.74 feet, North 76 degrees 27 minutes 21 seconds West a chord length of 318.05 feet to a point, said point reference by an iron pin found North 87 degrees, 03 minutes, 44 seconds West, 1.00 feet,

thence; along the south line of Muskingum County, Deedbook 2233, Page 261, South 87 degrees 03 minutes 44 seconds East 183.64 feet to an iron pin found,

thence; along a curve to the left having a radius of 723.74 feet, South 83 degrees 14 minutes 10 seconds East a chord length of 128.17 feet to an iron pin set,

thence; South 88 degrees 18 minutes 59 seconds East, 389.28 feet to an iron pin set,



thence; along the north line of Mid-East Ohio Vocational School, Deedbook 1068, Page 385, South 55 degrees 55 minutes 42 seconds West, 50.00 feet to the true place of beginning, containing 1.91 acres, more or less.
