SITUATED IN THE STATE OF OHIO, COUNTY OF MUSKINGUM, TOWNSHIP OF WAYNE, AND BEING PART OF THE NORTHWEST QUARTER OF FRACTIONAL SECTION 4, TOWNSHIP 12, RANGE 13, AND BEING ALL THOSE LANDS INTENDED TO BE DESCRIBED IN DEED VOLUME 1053, PAGE 219; BEING FURTHER BOUNDED AND DESCRIBED AS FOLLOWS:

COMMENCING AT THE NORTHWEST CORNER OF SAID FRACTIONAL SECTION #4, THENCE, SOUTH 04 DEGREES - 30 MINUTES - 00 SECONDS WEST, 450.00 FEET (BY DEED); THENCE, SOUTH 89 DEGREES - 52 MINUTES - 00 SECONDS EAST, 249.90 FEET (BY DEED); THENCE, NORTH 82 DEGREES - 58 MINUTES - 00 SECONDS EAST, 300.15 FEET TO A POINT; THENCE, NORTH 83 DEGREES - 11 MINUTES - 56 SECONDS EAST, 40.00 FEET TO AN IRON PIN FOUND ON THE SOUTH LINE OF WHEELING AVENUE, AND THE TRUE POINT OF BEGINNING FOR THE PARCEL HEREIN INTENDED TO BE DESCRIBED; THENCE, NORTH 81 DEGREES - 46 MINUTES - 22 SECONDS EAST, 49.93 FEET TO AN AXLE FOUND AT THE NORTHWEST CORNER OF THOSE LANDS DESCRIBED IN DEED VOLUME 526, PAGE 221; THENCE, SOUTH 02 DEGREES - 26 MINUTES - 27 SECONDS EAST, 237.48 FEET TO AN IRON POST FOUND; THENCE, SOUTH 85 DEGREES - 56 MINUTES - 00 SECONDS WEST, 49.44 FEET TO AN IRON PIPE FOUND; THENCE, NORTH 02 DEGREES - 30 MINUTES - 16 SECONDS WEST, 233.85 FEET TO THE POINT OF BEGINNING, AND CONTAINING 0.268 ACRES MORE OR LESS.

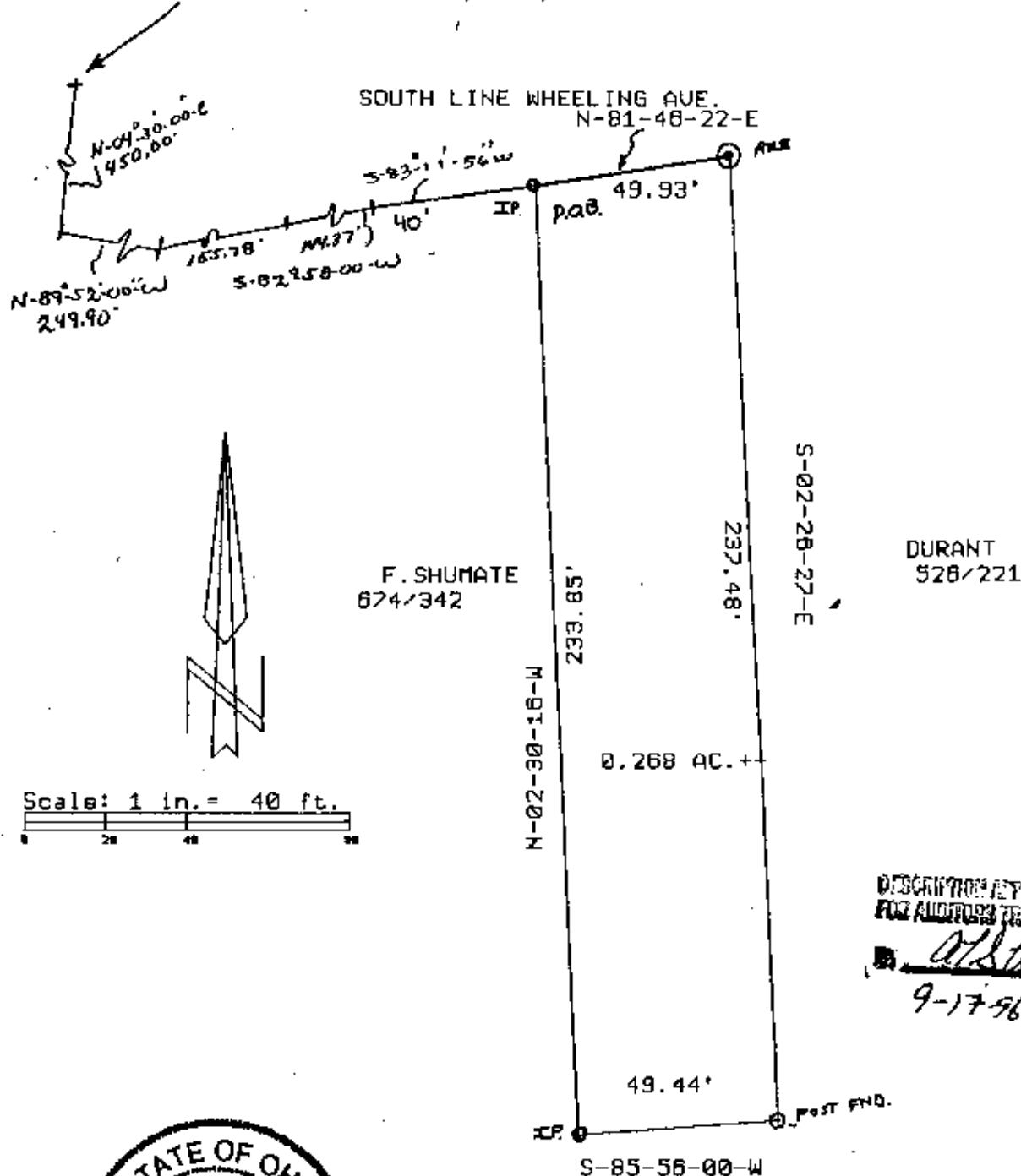
