LEGAL DESCRIPTION FOR 1556 WHEELING AVENUE

Situated in the State of Ohio, County of Muskingum, Township of Wayne, and being part of the northwest quarter of Section 4, Township 12, Range 13, and being all those lands intended to be described in Deed Volume 1696, page 299; being further bounded and described as follows:

Commencing at the northwest corner of said Section 4, thence, south 04 degrees – 30 minutes – 00 seconds west, 450.00 feet to a point on the south line of Wheeling Avenue; thence, south 89 degrees – 52 minutes – 00 seconds east, 249.90 feet to a point; thence, north 82 degrees – 58 minutes – 00 seconds east, 15.71 feet to an iron pipe found on the south line of said Wheeling Avenue, and the true *point of beginning* for the parcel herein intended to be described;

Thence, continuing north 82 degrees – 58 minutes – 00 seconds east, 40.03 feet to an iron pipe found;

Thence, leaving said Wheeling Avenue, south 04 degrees – 45 minutes – 13 seconds west, 140.20 feet to a one inch (1") bolt found;

Thence, south 83 degrees – 19 minutes – 06 seconds west, 39.97 feet to an iron pipe found;

Thence, north 04 degrees – 44 minutes – 59 seconds east, 139.95 feet along the east line of a sixteen foot (16') right-of-way to the *point of beginning*, and containing 0.126 acres more or less.

Bearings described herein are based upon assumed azimuth and to be used for angle purposes only.


Iron pins set are 5/8" rebar with yellow identification cap (Finley S-7222).
