COMMENCING AT THE NORTHEAST CORNER OF THE NORTHWEST QUARTER OF OF SECTION FOUR; THENCE NORTH 85 DEGREES 07 MINUTES 00 SECONDS WEST 596.00 FEET (BY DEED) TO A POINT; THENCE SOUTH 04 DEGREES 49 MINUTES 00 SECONDS WEST 296.00 FEET (BY DEED) TO A POINT INT THE CENTER OF COUNTY ROAD 604; THENCE SOUTH 43 DEGREES 24 MINUTES 00 SECONDS EAST 120.49 FEET (BY DEED) TO A POINT IN THE CENTER OF COUNTY ROAD NO. 604; THENCE WITH A CURVE TO THE RIGHT ALONG THE CENTER OF COUNTY ROAD NO. 604 HAVING A RADIUS OF 1142.92 FEET (CHORD BEARING SOUTH 36 DEGREES 10 MINUTES 49 SECONDS EAST 359.69 FEET) AN ARC DISTANCE OF 361.18 FEET TO A POINT, SAID POINT BEING THE PLACE OF BEGINNING OF THIS TRACT; THENCE CONTUNING ALONG THE CENTER OF COUNTY ROAD NO 604 WITH A CURVE TO THE RIGHT HAVING A RADIUS OF 1145.92 FEET (CHORD BEARING SOUTH 25 DEGREES 08 MINUTES 38 SECONDS EAST 106.01 FEET) AN ARC DISTANCE OF 106.05 FEET TO A POINT; THENCE SOUTH 61 DEGREES 16 MINUTES 02 WEST 302.67 FEET TO A POINT MARKED BY A 3/4" IRON PIPE FOUND, PASSING A POINT MARKED BY AN EXISTING IRON PIPE AT 95.01 FEET; THENCE NORTH 28 DEGREES 44 MINUTES 00 SECONDS WEST 110.33 FEET TO A POINT MARKED BY A 5/8" REBAR SET; THENCE NORTH 62 DEGREES 06 MINUTES 15 SECONDS EAST 309.34 FEET TO THE PLACE OF BEGINNING, PASSING A POINT MARKED BY A 5/8" REBAR AT 179.74 FEET.

CONTAINING 0.761 ACRES, SUBJECT ALL EASEMENTS OF RECORD.

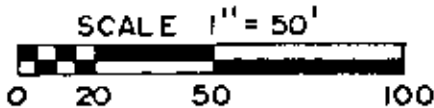

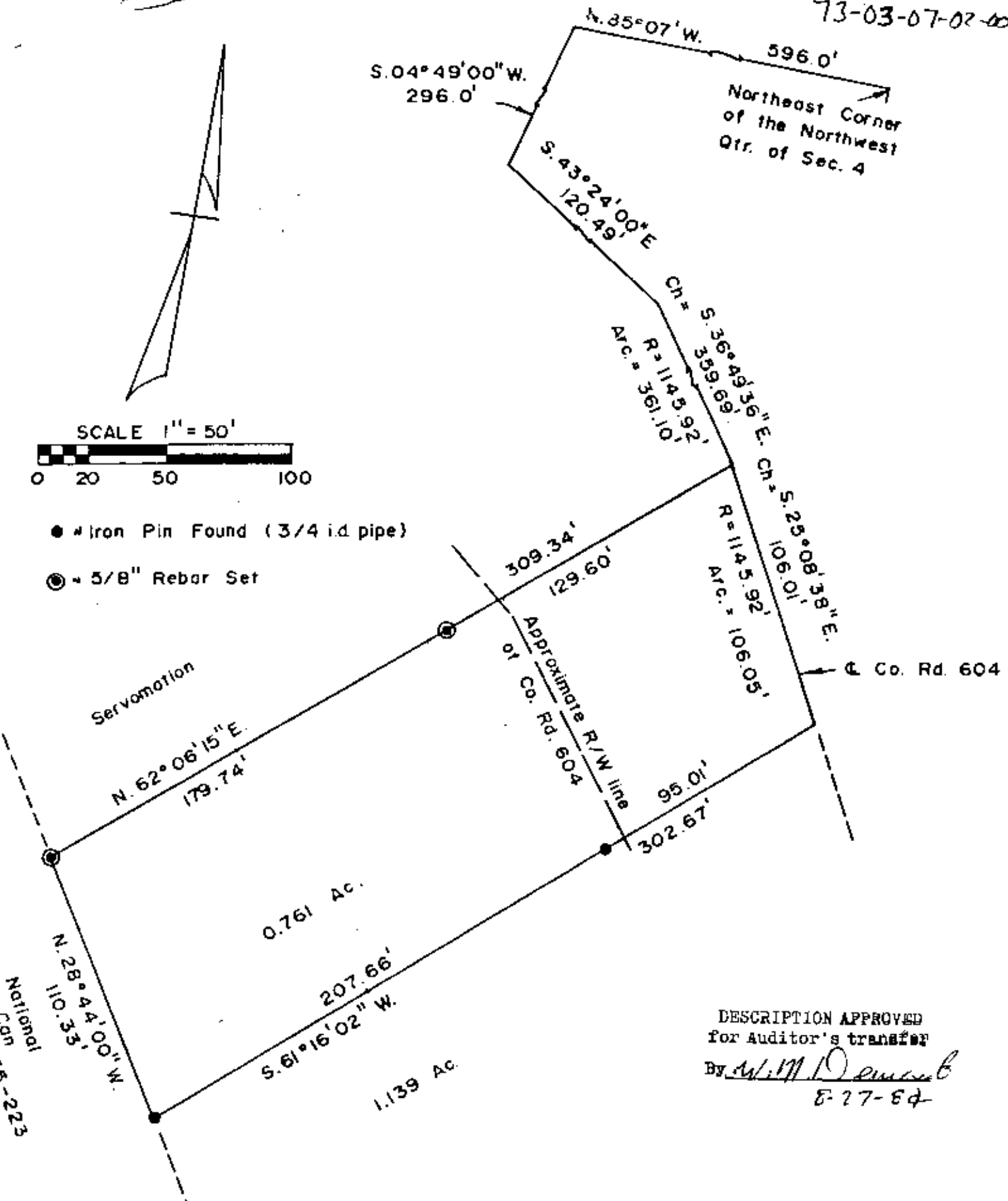
