DESCRIPTION OF SURVEY FOR ROBERT MAKIN

Being part of Section #4, Township #12, Range #13, of the Congress Lands East of the Scioto River, **being all of** the Robert and Diane Makin property recorded in Deed Book Volume 1158, Page 889 of said county's deed records, further being known as Muskingum County **Auditor's Parcel Number 73-03-08-34-000**, and more particularly described as follows;

Commencing at an iron pipe (found) at the Southwest corner of Lot #1 of Sandy Ridge Subdivision recorded in Plat Book 7, Page 54; **THENCE South 03 degrees 27 minutes 25 seconds West 30.00 feet** to an unmarked point in the centerline of Sharon Avenue (State Route #146), also being the place of beginning for the property herein intended to be described:

- #1- THENCE South 88 degrees 53 minutes 40 seconds East 7.60 feet along said Sharon Avenue to the unmarked common corner for said Makin property and for the Glenn Winters property recorded in Official Record Volume 1555, Page 217;
- #2- THENCE South 03 degrees 04 minutes 25 seconds West 389.93 feet leaving said road and along the common line for said Makin and Winters property line and West line of the M & J Paul property recorded in Official Record Volume 1556, Page 817, to an iron pipe (found) at a common corner for said Makin and Paul properties, also being on the North line of the M & J Paul property recorded in Deed Book Volume 1160, Page 605, passing an iron pin (found) at 34.86 feet;
- #3- THENCE North 89 degrees 56 minutes 30 seconds West 60.00 feet along the common line for said Makin and Paul property to an iron pipe (found) at a common corner for said Makin property and for the Terry & Marybelle Ford property recorded in Official Record Volume 1517, Page 486;
- #4- THENCE North 03 degrees 03 minutes 45 seconds East 391.03 feet along the common line for said Makin and Ford properties to an unmarked point in the centerline of said Sharon Avenue, passing an axle (found) at 365.21 feet;
- #5- THENCE South 88 degrees 53 minutes 10 seconds East 52.43 feet along said Sharon Avenue to the place of beginning, containing 0.54 acres, of which 0.04 acres are within the right of way for said Sharon Avenue (State Route #146).

The bearings within this description are based on State Plane Coordinate Grid (Ohio South 1983) derived from Solar Observations. Iron pins (set) are 5/8" rebar with identification caps (C.R.Harkness P.L.S.6885).
