BEING A PART OF THE NORTHEAST QUARTER OF SECTION 4, TOWNSHIP 12, RANGE 13, OF THE CONGRESS LANDS EAST OF THE SCIOTO RIVER, WAYNE TOWNSHIP, MUSKINGUM COUNTY, OHIO AND BEING FURTHER DESCRIBED AS FOLLOWS:

COMMENCING AT AN IRON PIN SET AT THE SOUTHEAST CORNER OF THE NORTHEAST QUARTER OF SECTION 4; THENCE NORTH 85 DEGREES 31 MINUTES 09 SECONDS WEST 63.41 FEET TO AN IRON PIN SET, SAID IRON PIN BEING THE PLACE OF BEGINNING OF THE TRACT HEREIN INTENDED TO BE DESCRIBED; THENCE CONTINUING NORTH 85 DEGREES 31 MINUTES 09 SECONDS WEST 121.89 FEET TO AN IRON PIN SET AT THE SOUTHEAST CORNER OF A TRACT CONVEYED TO P. R. KUNTZ AS RECORDED IN DEED VOLUME 929, PAGE 230 OF THE MUSKINGUM COUNTY DEED RECORDS, SAID IRON PIN BEING SOUTH 85 DEGREES 31 MINUTES 09 SECONDS EAST 46.00 FEET FROM THE SOUTHWEST CORNER OF SAID KUNTZ TRACT; THENCE ALONG THE EAST LINE OF SAID KUNTZ TRACT NORTH 05 DEGREES 59 MINUTES 36 SECONDS EAST 341.86 FEET TO A POINT IN THE CENTER OF CLAY PIKE, PASSING AN EXISTING IRON PIN (AXLE) AT 320.21 FEET; THENCE ALONG SAID ROAD NORTH 70 DEGREES 40 MINUTES 54 SECONDS EAST 43.18 FEET TO A POINT IN SAID CENTER; THENCE LEAVING SAID ROAD SOUTH 13 DEGREES 49 MINUTES 03 SECONDS EAST 236.16 FEET TO AN IRON PIN SET, PASSING AN IRON PIN SET AT 23.79 FEET; THENCE SOUTH 04 DEGREES 48 MINUTES 55 SECONDS WEST 134.95 FEET TO THE PLACE OF BEGINNING.

CONTAINING 0.773 MORE OR LESS ACRES, SUBJECT TO ALL LEGAL ROAD RIGHT-OF-WAY OF CLAY PIKE AND ALL OTHER APPLICABLE EASEMENTS.

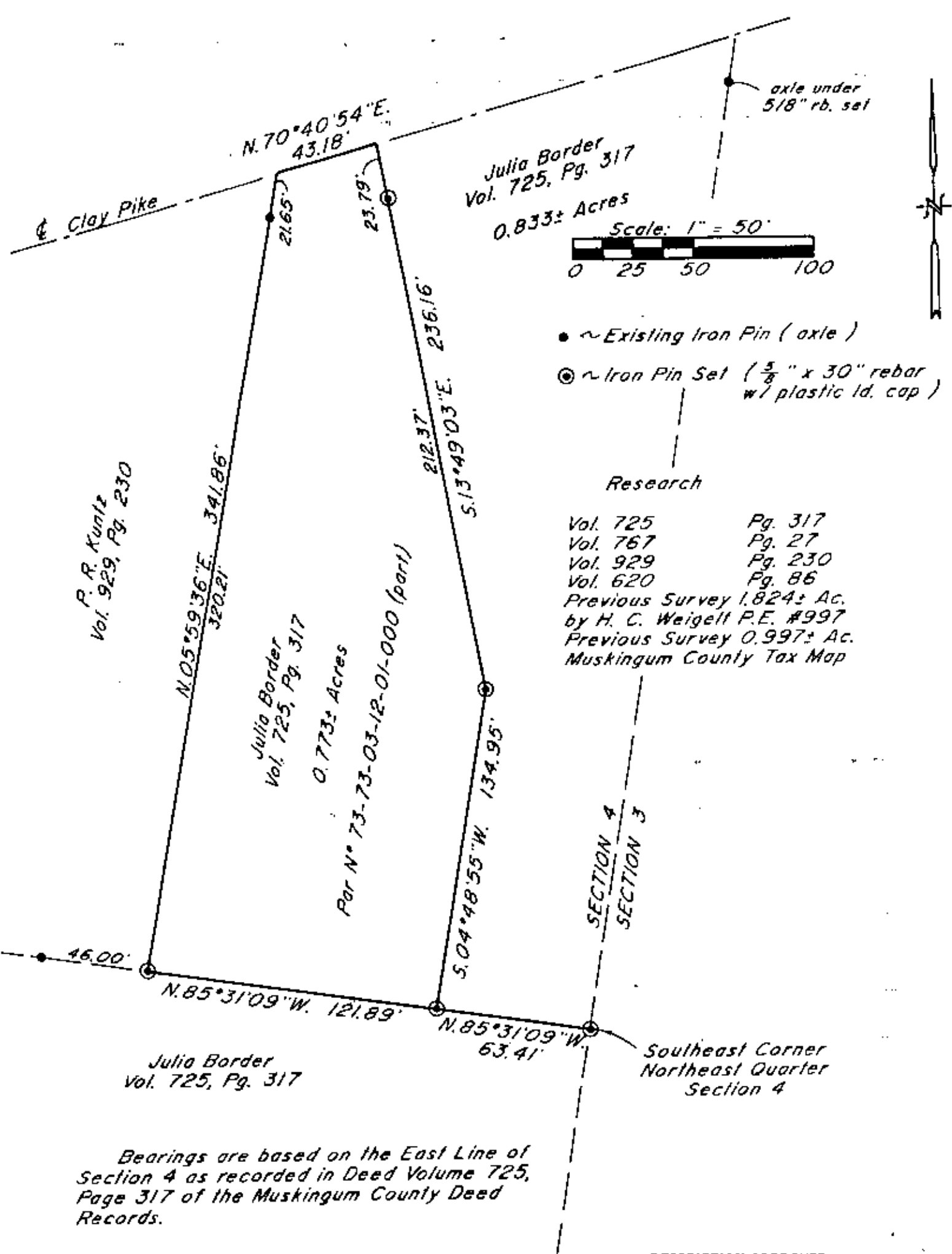
